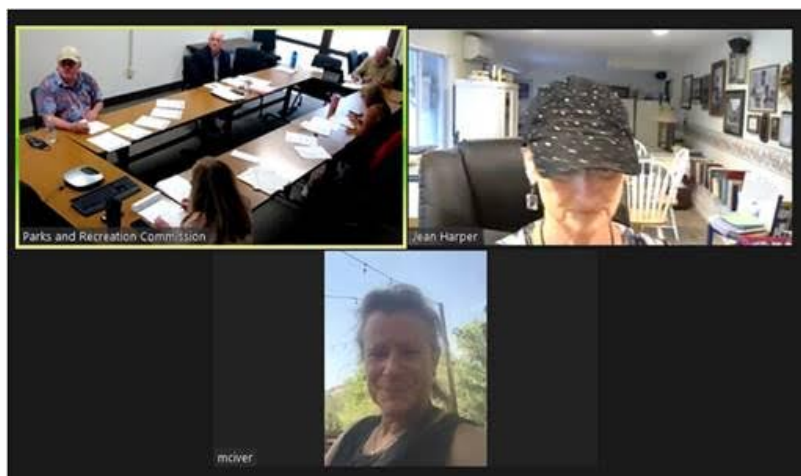
My, my, my...the tangled web you weave when government practices to deceive...

It is apparent by John Arenz' email below that Parks and Rec has not yet removed his email from the [PRC@edcgov.us](mailto:prc@edcgov.us) group email address - Arenz resigned months ago. Makes you wonder if Charlie Callahan is still in the PRC group, and if Commissioners Tom Conwell or Julia McIver have even been added **as required by law**. How is the public supposed to exercise their rights and hold them accountable if they can't be contacted??

Lord knows who else these government shills are surreptitiously sharing correspondence with—perhaps their good buddies at the American River Conservancy and the River Mafia Mob???

Furthermore, the 9/17/20 and the 8/20/20 PRC meetings proceeded unlawfully despite my correspondence to Lori Parlin, the BOS, PRC and CAO staff advising that **both** meetings failed to be posted **72 hours in advance as lawfully required under the Brown Act**.

Discussion over the missing public comments/documents from the 6/18 PRC meeting took place under the direction of Vickie Sanders who distributed the materials to Commissioners Conwell, Payne, and Lowery that you see spread out on the table in the below snapshot. Lori Parlin and staff never acknowledged receipt of those materials, nor were they posted **as required by law**.



Per Vickie Sanders, the 8/20 PRC audio was not posted because it "did not record", but neither Vickie or Lori responded to any of my inquiries which was the topic discussed during the 9/17 PRC Agenda Item #6 – audio recordings. Vickie blamed minutes/audio discrepancies on "technical difficulties" and staff turnover. BALONEY!!!

Trish Sweeney was a party to the Parks and Rec fraudulent actions, therefore she is complicit and liable. However Vickie Sanders announced that Trish Sweeney had just submitted her resignation from Parks and Rec at 10 AM on Thursday, September 17th. How convenient! I guess my announcement about Jack Sweeney's threat of "repercussions" for mentioning the Sweeney's complicity at the BOS didn't go over too well with county counsel. 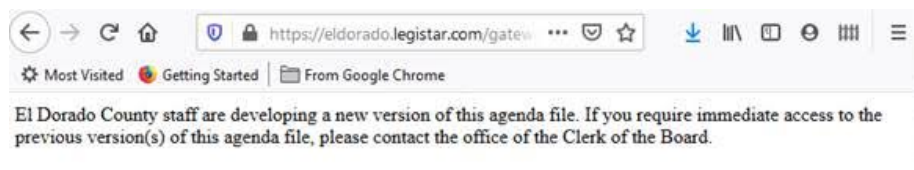

Lori,

Per my 9/4 conversation with Kyra, I presume that Trish Sweeney is still moonlighting for PRC and she responsible for posting the PRC audio/videos and the agendas 72 hours in advance as required by the Brown Act. You are aware that Don Ashton has unlawfully blocked my ability to communicate electronically with most staff. Therefore the responsibility falls on you to ensure this message is responded to, properly conveyed, and publicly distributed via Legistar and posted to the 9/17 PRC agenda in a timely manner.

When I checked the calendar yesterday morning to see if the 8/20 PRC video had been posted, it was still missing from the calendar.
