Please ensure that the entirety of this correspondence is entered into the public record under Open Forum.

Apparently the Parks & Rec Commissioners need some remedial tutoring in the requirements of the Brown Act and obligations under their Principal Agent Oaths of Office. The Bureaucratic Shenanigans are worse than ever, making it obvious you have something to hide. Since county counsel and the BOS are permitting these meetings to proceed outside of the law, then they become complicit and liable for fraud.

Pursuant to the constitutional mandates imposed upon them, by and through their oaths, there is no discretion on the part of public officers to oppose the Constitutions and their oaths, nor to be selective about which, if any, mandates and protections in the Constitutions they support. The mandates and protections set forth in the Constitutions are all-encompassing, all-inclusive and fully binding upon public officers, without exception, as they are upon you.

During the 9/1/20 BOS Open Forum I apprised staff that Trish Sweeney from Assemblyman Frank Bigelow's office was apparently moonlighting by facilitating the illegitimate August 20th PRC meeting. Wayne Lowery claimed he didn't know that Trish was related to Jack Sweeney, which is another LIE because each of the Commissioners received a copy of the Bigelow affidavit containing the facts surrounding Jack and Trish's involvement in the **Chili Bar lawsuit and other land acquisitions by the American River Conservancy and State Parks** using tax payer funded resources.

I further stated that Mr. Lowery and Julia McIver have a conflict of interest due their ARC membership which strategically positions them to influence the BOS on behalf of the ultra-liberal American River Conservancy.

Additionally I also reported the facts concerning Kris Payne after he once again showed his disrespect when he got up and walked out of the room while I was making public comments. In so doing Kris demonstrated that the Brown Act and the broad Constitutional Rights of the Public are irrelevant. Furthermore, the audio of the 8/20 PRC meeting still has not been posted as required by law.

To top it off, after I made my remarks to the BOS about the fraudulent PRC meetings, I received an overt threat from former Supervisor Jack Sweeney speaking on behalf of his daughter-in-law Trish Sweeney who works for Assemblyman Frank Bigelow.

When a public official has knowledge of wrong doing, but fails to take remedial action, then they become complicit and personally liable. In the case of intentional "dishonest acts" by public officials, advisory boards or commissions, it is a fact that they are NOT covered by the county's Risk Management policy. Under USGC Title 18, Sections 241 & 242, respectively Conspiracy Against Rights and Deprivation of Rights Under Color of Law, these are federal offenses. Kris Payne, Brian Veerkamp, Don Ashton, Vickie Sanders, and other public officials have already received their notifications of legal responsibility which is the first essential of due process of law.

The purpose of the discussion is to permit a member of the public to raise an issue or problem. You failed to answer public inquiries which deprives the public of redress of grievances and due process.

This request still has not been publicly distributed and posted as initially requested on Tuesday 9/15/20 as required BY LAW.

Therefore I demand that you personally reply *immediately* to the following inquiries concerning today's illegitimate PRC meeting:
