

AGREEMENT FOR SERVICES #437-S1211(832)  
AMENDMENT III

This Amendment III to that Agreement for Services #437-S1211, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and TracNet Corporation, a California corporation, duly qualified to conduct business in the State of California, whose principal place of business is 1277 Adobe Lane, Pacific Grove, CA 93950; (hereinafter referred to as "Consultant");

**RECITALS**

**WHEREAS**, County has entered into a separate perpetual Software Product License Agreement with Consultant identified as Agreement #714-S0811 dated March 25, 2008 and subsequent amendments (hereinafter "License Agreement") for certain programs and services relating to automated criminal information and additional law enforcement/public safety operations and management; and

**WHEREAS**, Consultant has been engaged by County for a Software Maintenance Service Plan, in accordance with Agreement for Services #437-S1211 (#832), dated May 22, 2012 (hereinafter "Maintenance Agreement") and Amendment I dated June 20, 2017, and Amendment II dated June 26, 2018, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to amend the scope of work of the Agreement to add a new service to be performed by the Consultant; and

**WHEREAS**, the parties have mutually agreed to amend the Not to Exceed Amount in Article III to include "Exhibit A, Amendment, TracNet Software License Agreement", incorporated herein.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #437-S1211 (#832) shall be amended a third time as follows:

1. The scope of work of the Maintenance Agreement is revised to add the following service in accordance with "Exhibit A, Amendment, TracNet Software License Agreement" incorporated herein and made by reference a part hereof:

TracNet will build and provide a File Extract as follows:

1. Five (5) files as titled in the Lexis Nexis File Documentation dated 11/18/2019.
2. Fixed Length data including journal information and data information in the format defined in the above mentioned Lexis Nexis File Documentation.
3. Data File extraction and transmission of above files one time daily at agreed upon time.
4. Transmission of the five files to a designated server on the network via SFTP.
5. County to provide designated server, network connectivity and credentials.


2. The last sentence of ARTICLE III is hereby amended to read as follows:

The total amount of this Agreement shall not exceed \$1,360,957.63

If any provision or provisions of this amendment shall be held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

Except as herein amended, all other parts and sections of that Agreement #437-S1211 (#832) shall remain unchanged and in full force and effect. All provisions, attachments and upgrades of the Maintenance and License Agreements, previously attached, remain unchanged an in full force and effect.
