### <u>NINTH AMENDMENT TO</u> <u>AGREEMENT TO MAKE SUBDIVISION IMPROVEMENTS</u> <u>FOR CLASS 1 SUBDIVISION</u> <u>BETWEEN COUNTY AND OWNER</u>

THIS NINTH AMENDMENT, to that certain Agreement to Make Subdivision Improvements for Class 1 Subdivision Between County and Owner (hereinafter referred to as the "Agreement"), made and entered by and between the COUNTY OF EL DORADO, a political subdivision of the State of California, (hereinafter referred to as "County"), and SILVER SPRINGS EL DORADO COUNTY, INC., a corporation, duly qualified to conduct business in the State of California, whose principle place of business is 707 Aldridge Road, Suite B, Vacaville, California 95688 (hereinafter referred to as "Owner"); concerning SILVER SPRINGS, UNIT 1 (hereinafter referred to as "Subdivision"); the Final Map of which was filed with the El Dorado County Board of Supervisors on the 26th day of September, 2006.

#### **RECITALS**

WHEREAS, County and Silver Springs El Dorado County, Inc. entered into that certain Subdivision Improvements Agreement on September 26, 2006, in connection with the Subdivision, thereafter amended on July 17, 2007, April 6, 2010, May 14, 2013, November 5, 2013, September 16, 2014, October 13, 2015, November 10, 2016, and February 26, 2019 copies of which Agreement, as amended, is incorporated herein and made by reference a part hereof (herein after referred to as "Agreement");

WHEREAS, the Agreement, as amended, requires Owner to complete the subdivision improvements thereunder on or before September 24, 2020, and Owner has not completed all of the improvements, but Owner has requested an extension of time to complete the subdivision improvements subject to the terms and conditions contained herein, to September 24, 2021;

**NOW, THEREFORE**, the parties hereto, in consideration of the recitals, terms, and conditions herein, do hereby agree to amend the terms of the Agreement in this Ninth Amendment to read as follows:

**I.** Section 3 is amended to read as follows:

3. Complete the Subdivision improvements contemplated under this Agreement on or before September 24, 2021.

Except as herein amended, all other parts and sections of that certain Agreement dated September 26, 2006, as thereafter amended, shall remain unchanged and in full force and effect.
