FIRST AMENDMENT TO AGREEMENT FOR SERVICES #3139

THIS FIRST AMENDMENT to that Agreement for Services #3139 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Eric S. Hill, a sole proprietor, duly qualified to conduct business in the State of California, doing business as Hilltop Tree Service, whose principal place of business is 2561 Hoot Owl Ravine Road, Placerville, California 95667 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to assist County in providing certified arborist services and reports, and tree and brush cutting services for matters of public safety pursuant to Agreement for Services #3139, dated July 23, 2018, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of November 8, 2020 for one (1) additional year, amending ARTICLE II, Term;

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$90,000, for a new not-to-exceed amount of \$155,000, and to include a new fee schedule for the extended term of the Agreement, amending ARTICLE III, Compensation for Services, and adding Amended Exhibit A, Amended Fee Schedule;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

I. ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

ARTICLE II.

Term: This Agreement shall become effective when fully executed by both parties hereto and shall cover the period of November 9, 2018 through November 8, 2021.

II. ARTICLE III, Compensation for Services, the second and third paragraphs of the article are amended to read as follows: For the purposes hereof, for the period beginning with the effective date of this Agreement and continuing until the day before the effective date of this First Amendment to the Agreement, the billing rates shall be in accordance with Exhibit A, marked "Fee Schedule," incorporated herein and made by reference a part hereof.

For the period beginning with the effective date of this Amendment and continuing through the remaining term of the Agreement, as amended, the billing rates shall be in accordance with Amended Exhibit A, marked "Amended Fee Schedule," incorporated herein and made by reference a part hereof.

The total amount of this Agreement shall not exceed \$155,000, inclusive of all Work Orders, costs, taxes, and expenses.

Except as herein amended, all other parts and sections of Agreement for Services #3139 shall remain unchanged and in full force and effect.
