### COVID-19 Homeless Management Strategy (Project Roomkey)

### COVID-19 Homeless Management Strategy

In the face of the COVID-19 pandemic, the Community Action Team for Homelessness implemented a three-phase plan:

- Phase 1 Active outreach, education and support to keep people in place in the camps
- Phase 2 Implementing Project RoomKey, placing high risk, vulnerable individuals in motels
- Phase 3 Planning for a surge

Involved multiple community partners, including County Agencies, Healthcare Providers, the Sheriffs Dept and Volunteers

Today's report focuses on the progress and status of Project RoomKey

#### Project RoomKey Status

Project RoomKey is a statewide initiative that provides temporary housing for homeless/unsheltered persons during the COVID-19 pandemic.

We systematically interviewed and screened the most vulnerable unsheltered population, identifying those at highest risk for COVID-19 complications.

- South Lake Tahoe 22 Hotel Rooms
- Pollock Pines 26 Hotel Rooms

The Program seized the opportunity of motivated individuals in a fixed location to add case management and navigation services to pilot the feasibility of supporting individuals access transitional housing.

#### Case Management/Navigation Services

Each individual in the RoomKey Program develops an action plan with clear personal goals and expectations for participating in the program.

The program provides needed healthcare and social services; ID's, social security, health coverage, VA support, transportation.

Support provided by a consortium of local public health service providers, legal/law enforcement and volunteers, including the following:

- Transformational Services for Homelessness/Unsheltered
- Transitional Housing
- Veterans Services
- Community Reintegration Services
- Primary Healthcare

The program includes support from Marshall, Barton, Tahoe Coalition for Homeless, Public Health, Social Services-APS & IHSS, HOT, a range of local service providers and significant support from local volunteers trained as "Community Health Workers".

#### Program Plans

- Project RoomKey continuing through end of December 2020 using available State funds
- Exploring extension through March 2021 (Impact on vulnerable individuals if program terminates during winter months)
- Pathways program for winter housing adopting a similar navigation model
- Assessing impact of migration to Project HomeKey in South Lake Tahoe
- Working to extend scope and impact of Coordinated Entry
- Working to further advance coordination of services

#### Learning Points and Challenges

- Sustainability of funding for project RoomKey
- Transition from RoomKey to HomeKey
- Resourcing for case management / navigation
- Access to transitional & affordable housing
- Access to winter shelter
- Ongoing impact of COVID-19






#### COVID-19 Funding (Project Roomkey)

- \$1,368,000 Hotels, meals, security & case management
  - \$229k \*COVID-19 Emergency (\$109k County & 119k COC)
  - \$90k \*CMSP CERG (PH allocation Noncongregate sheltering)
  - \$93k \*Preparedness Funding
  - \$106k \*CARES Act Funding
  - \$850k \*HEAP Funding (Repurposed)

#### Project Roomkey Expenditures

- \$816k total expended (May-Oct)
  - \$640k hotels
  - \$70k meals
    - \$41k Upper Room
    - \$29k Probation
  - \$102k Security (BOLT Staffing)
  - \$2,800 cleaning & damages
- \$1.3m projected (Jan 31, 2021)
- \$200k set-aside for cleaning & damages

#### Remaining Funding

- \$437k \*ESG-CV Round 1(COC Emergency Solutions Grant COVID allocation)
  - \$100k Future Hotel Costs
  - \$75k Street Outreach
  - \$75k Homeless Prevention
  - \$163,900 Rapid Rehousing
- \$467k \*Whole Person Care Funding
  - \$108k TA Provider (Homebase)
  - \$204k 60% of Program Manager (Housing & Homeless Programs)

#### Remaining Funding

#### **Future Funding**

- \$2.8m PLHA (Permanent Local Housing Allocation)
  - \$480k-\$680k/year for 5 years, with anticipated ongoing funding
    - 40% contingent upon approval...2 case managers/permanent housing specialists
    - 60% developer subsidies & first time homebuyer subsidies to increase permanent housing outcomes
- \$716k \*ESG-CV Round 2 (CoC)
  - Funding announcement not yet released (pending award)
- **\$647k \*HHAP Round 2** (\$306k County/\$341k CoC)
  - Allocations determined but Funding announcement not yet released

## Joint Policy Statement/Navigation Center

#### Joint Policy Statement on Homelessness

- April 2020 (Board of Supervisors & Placerville City Council)
- Documents a commitment between the County and the City of Placerville and provides direction to staff from both organizations in regards to homelessness activities

#### Joint Policy Statement on Homelessness

- **Action 2:** Authorize staff of both jurisdictions, working in conjunction with the Sheriff's Homeless Outreach Team, to explore properties/facilities and determine the feasibility of such properties to provide temporary housing and services to the homeless.
- May 2020 Meeting/call with County staff (CAO, HHSA, Facilities & Sheriff), City of Placerville Staff, and Homebase
  - Homebase recommended a multi-disciplinary navigation center and programs:
    - A. Drug and Alcohol Rehabilitation Services
    - B. Mental Health Counseling
    - C. Temporary Housing
    - D. Identification of Permanent Housing
    - E. Employment Counseling, meals & other related services

#### Navigation Center Needs

- 50 beds (expand to 80 during winter)
- Office space
- Restrooms & Showers
- Lockers
- Kitchen
- Activity areas
- Private rooms (families)
- Outdoor space (pets, activities, bicycles & storage)

#### **Navigation Center**

- June 2020 Meeting with Facilities & Commercial Real Estate Broker
- August 2020 30 properties down to about 10
- September 2020 5 property owners willing to entertain leasing or selling their property to El Dorado County for the Navigation Center
- October 2020 tour of 5 properties
- What's next?
  - \$850k HEAP/HHAP Swap (June 2021)
  - Operating Costs/Permanent Ongoing Funding
  - \$2.8m PLHA (Permanent Local Housing Allocation)

#### Homekey Program

#### Homekey Program

- Tahoe Coalition for the Homeless & Tahoe Regional Planning Agency
  - Applied for & received funding reservation
  - \$9.5 million
  - Large portion goes directly to acquisition
  - Smaller portion funds 2-year operating subsidy
  - Interim housing initially then rehabbed into permanent housing
  - Supportive services provided on-site

#### Homekey Program

- Three properties currently in escrow
  - 68-70 total units
    - Stabilizing units, SRO's & apartments
- Ongoing award administration with HCD
- Completing acquisition/escrow process
- Hiring and training new staff members
