Introduction

El Dorado County is experiencing an extraordinary increase in its older adult population. In 2000, there were 26,023 residents in our County who were age 60 and over, representing 16.7% of the total population. Between 2000 and 2020, the aging population is expected to more than double, with one in four residents over the age of 60. According to the U.S. Census Bureau, 2008 American Community Survey, approximately one in eight individuals is living at home in our community with a disability, of which, more than one-third are 65 years and older. There is a critical need for personal assistance services to people with chronic and disabling conditions to remain safely in their homes.

In-Home Supportive Services (IHSS) is an alternative to costly out-of-home care, providing financial assistance for services to eligible older adults and persons with disabilities, so they can remain safely in their own homes. The Public Authority was established to provide and promote a service delivery model through skilled providers who assist in maximizing the potential of these vulnerable individuals to live independently and participate in their community.

The El Dorado County IHSS Public Authority is pleased to present the 2008-2009 Annual Report, which provides a brief overview of the IHSS program; the Public Authority's mandates and its role in supporting IHSS; and the IHSS Advisory Committee's functions. This report updates the Public Authority's activities and also highlights many of the accomplishments of this past year.

The IHSS Public Authority and IHSS Advisory Committee will continue to facilitate and further enhance the availability and quality of In-Home Supportive Services for both consumers and care providers. We remain committed to improving the lives of IHSS consumers and providing the best service possible with the resources available to us. We look forward to another year of working collaboratively with all IHSS stakeholders to secure this goal.

The IHSS Program

California's In-Home Supportive Services (IHSS) program, created in 1973, was designed as an alternative to out-of-home care. Through a funding mix of federal, state and county dollars, the IHSS program allows eligible recipients who are elderly, blind or disabled to stay in their own homes by paying providers to assist them with tasks that they are not able to manage on their own. Without IHSS services, many recipients would be forced to find more costly and less desirable, out-of-home care such as nursing homes or board and care facilities to meet their needs.



IHSS Eligibility


To be eligible for IHSS, a person must be either over 65 or disabled, and be receiving or meet the financial criteria for Medi-Cal and State Supplemental Security Income/State Supplementary Payment (SSI/SSP) benefits.

It is the El Dorado County IHSS Social Workers who are responsible for determining eligibility and assessing a recipient's need for specific services and determining the number of hours of home care the recipient can receive.

Once a recipient has been assessed and determined eligible, a Notice of Action is sent to the recipient which lists the number of authorized hours for each task approved under the IHSS Program. The recipient, upon receiving the Notice of Action, may then begin working with a care provider in order to have his/her needs met.


El Dorado County IHSS Demographics

As of June 2009, El Dorado County had 990 IHSS recipients authorized for services. IHSS recipients are adults living with disabilities (45%), older adults (44%), and children living with disabilities (10%).




El Dorado County had 880 paid providers in June 2009. The majority of care providers are female (80%) and under the age of 60 (82%). The average number of paid hours per month in fiscal year 2008-2009 was 93,798. Care providers earned \$9.00 per hour.

Gender of Care Providers



Of the total number of care providers in June 2009 (1,053 providers), more than half (592) were non-family providers of care. Such individuals included relatives other than a parent, spouse, or child, friends, neighbors, or registry. Of the total number of family care providers (461), nearly half were parents providing care (222), most of whom were mothers (90%), followed closely by child care providers (188), most of whom were daughters (81%).



IHSS Public Authority Statutes

In July 1999, the California Legislature enacted AB 1682, requiring that all California counties act as, or establish an "employer of record" for IHSS workers, and establish a recipient-majority advisory committee by January 2003. The El Dorado County Board of Supervisors established the El Dorado County IHSS Public Authority in September 2002. The IHSS Public Authority's Governing Board is comprised of the five members of the County of El Dorado's Board of Supervisors. They look to the IHSS Advisory Committee for information and recommendations regarding In-Home Supportive Services.

By statute, California Welfare and Institutions Code Section 12301.6, a Public Authority is required to do the following:



- Establish an IHSS Care Provider Registry and referral system under which IHSS providers may be referred to recipients
- Perform provider background checks on IHSS Registry Providers
- Provide training for providers and recipients
- Comply with any requirements of the personal care option necessary to maintain federal financial participation
- Perform any other statutory functions related to the delivery of IHSS

The El Dorado County IHSS Public Authority became operational in September of 2003, with full staffing in March of 2004. Since its inception, the IHSS Public Authority has given care providers in El Dorado County a central location they can contact for any questions or concerns they may have about their recipient's authorized hours, suspected abuse, IHSS procedures, IHSS provider enrollment, registry employment opportunities, free education and training, provider health benefits, worker's compensation claims, timesheet and payroll questions, and assistance with resolving issues and conflicts.





IHSS Public Authority Staffing & Expenditures

The IHSS Public Authority contracts with El Dorado County's Department of Human Services (DHS), Community Services Division, to administer and provide dedicated personnel for the Public Authority functions. The IHSS Public Authority staff consists of one Program Manager, two Registry/Training Specialists, and one Secretary position. In fiscal year 2008-2009, the PA expenditures for salary and benefits, services, supplies, and other charges totaled approximately \$324,237.

IHSS Care Provider Registry

The IHSS Care Provider Registry is operated by the IHSS Public Authority and provides referral lists of screened care providers to IHSS recipients who need a care provider to assist them with personal care or household services. The free registry referral lists are generated to match care providers with recipients based on information such as services, location, gender and special skills. The Public Authority retains the exclusive right to screen applicants and suspend or terminate providers from the IHSS Care Provider Registry. Potential care providers must complete the following before they are accepted on the Registry:

- Complete a IHSS Registry Application & sign registry acknowledgements
- Obtain a Dept. of Motor Vehicles printout of the last three years
- Pass a one-on-one interview screen with Registry staff
- Attend an introductory workshop on IHSS program and Registry procedures
- Pass at least three references
- Pass the Department of Justice and court record criminal background check

IHSS Provider Health Benefits

The Public Authority is responsible for administering benefits for up to 200 eligible IHSS providers. Benefits include health, dental and vision with no monthly premiums to the provider. In order for providers to become eligible they must be paid 70 or more hours per month for two consecutive months and continue to work the minimum hours in order to remain enrolled. If all the benefit openings are filled, the providers are placed on a wait list. Since March of 2004, the number of participants in the Symetra plan has grown and reached capacity in September 2008.

Care Provider & Recipient Classes

During the fiscal year 2008-2009, the Public Authority provided 26 free provider and recipient training workshops with the Family Caregiver Support Program to expand training opportunities to enhance the provider workforce throughout the county. Providers are also encouraged to participate in other senior and caregiver training and support group activities offered by the Department of Human Services. The Public Authority had 766 IHSS providers and recipients training hours in the fiscal year. In fiscal year 2008-2009, the following classes were provided:

Achievements of the IHSS Public Authority

The major accomplishments for the Public Authority (PA) in 2008-2009 include:

- Conducted 493 orientations and introductory Registry workshops for IHSS care providers to learn about the IHSS program regulations and rules, responsibilities of being a care provider, payroll guidelines, legal responsibilities, health and safety issues, fraud reporting, etc.
- Provided orientations and introductory Registry workshops twice a month in South Lake Tahoe to increase access to the PA and care providers on the Eastern Slope.



- Continued labor negotiations with the United Domestic Workers of America to discuss provider wages, benefits, and other conditions of employment.
- Collaborated in the development of the Alzheimer's Association Education Conference: "2009 Understanding Memory Loss: Flexible Approaches" conference for family and professional caregivers, social workers, and anyone interested in learning more about Alzheimer's Disease and related dementias.
- Assisted with National Memory Screening Day throughout the County.
- Disseminated information about vital services such as the IHSS and PA programs, IHSS Advisory Committee, MSSP, Family Caregiver Support Program, and Department of Homeland Security's "Preparing for Disaster for People with Disabilities and Other Special Needs."
- Attended 83.5 hours of staff training in areas such as IHSS Training Academy Ensuring Quality, World Class Customer Service, Communication, Mandated Reporter, Working with Dementia Behaviors, etc.
- Represented IHSS PA at health fairs in Pioneer Park and Greenwood.

The IHSS Advisory Committee

Under the statutory authority of the Welfare and Institutions Code 12301.6, the County created an Advisory Committee for In-Home Supportive Services. In September of 2002, by Ordinance No. 4612, the El Dorado County Board of Supervisors established the In-Home Supportive Services Advisory Committee as an independent advisory committee.

IHSS Advisory Committee Structure

The eleven member committee is composed of six representatives of current or past recipients of home care services, two representatives of current or past providers of private or IHSS homecare services, and three representatives of community members, preferably from a community-based organization, either volunteer or paid positions. Members are appointed by the IHSS Public Authority Governing Board to provide ongoing advice and recommendations regarding In-Home Supportive Services and the Public Authority services to the County Board of Supervisors, the Public Authority Governing Board, and the Department of Human Services. The Committee looks for individuals who are familiar with in-home care and can provide valuable input regarding issues that confront both recipients and providers of in-home services for the elderly and disabled in the community. - Upon training received from the El Dorado County's Sheriff's Department on the El Dorado County Emergency Operations System, the AC prepared and distributed handouts on "Preparing for Disaster" through the Care Connection Newsletter, for distribution to all IHSS providers and recipients.
- The AC researched and will continue to pursue possible participation in a Tri-County IHSS Advisory Committee Training and a California In-Home Supportive Services (CICA) conference.
- The AC developed and submitted a draft recipient binder in November 2008 to IHSS social workers for review and feedback.
- The AC provided continued financial support for the publication of the Care Connection Newsletter for distribution to IHSS providers and recipients.

IHSS Advisory Committee Achievements continued

- A subcommittee was convened to prepare a draft IHSS Advisory Committee budget for the 2009-2010 fiscal year for submission to the Board of Supervisors.
- Held discussions regarding proposed modifications to the IHSS AC Operational Guidelines to enable appropriate mileage reimbursement to persons providing transportation to the AC meeting.
- A subcommittee was convened to determine the AC's role within County government structure.



- Two in-services were arranged on the available services and resources through the El Dorado Center for the Visually Impaired and CICA.
- Two guest speakers provided continuing education opportunities for AC members. An instructor and aging specialist from the El Dorado Center—Folsom Lake College discussed the changing needs of the aging population in El Dorado County and a representative from the Center for Non-Violent Relationships discussed potential indicators of abuse.
