PRE-PASSAGE SUMMARY OF PROPOSED URGENCY ORDINANCE ORDINANCE NO. XXX-2020

AN URGENCY ORDINANCE ADOPTING AN INTERIM MORATORIUM ON THE CULTIVATION OF INDUSTRIAL HEMP FOR ALL PURPOSES WITHIN THE UNINCORPORATED AREAS OF THE COUNTY OF EL DORADO PENDING THE STUDY AND DEVELOPMENT OF REASONABLE REGULATIONS

Pursuant to California Government Code sections 65858(a) and 65090, the Board of Supervisors for the County of El Dorado hereby gives notice that, on December 15, 2020, at 10;00am in the Board of Supervisors' Hearing Room at 330 Fair Lane, Placerville, it will hear and vote on the passage of Urgency Ordinance xxx-2020 that would impose a temporary moratorium in the unincorporated area of the County on the cultivation of industrial hemp for all purposes, including cultivation by a hemp breeder or by an Established Agricultural Research Institution, for fortyfive days. Board is proposing to adopt this as an urgency ordinance pursuant to Government Code section 65858 for the immediate preservation of the public safety, health, and welfare in order to give County staff time to determine the impact of unregulated cultivation to my and develops reasonable regulations to mitigate those impacts. The Ordinance would prohibit any person or entity from cultivating industrial hemp for any purpose within the unincorporated areas of the County, except for a person who was issued a registration in 2020 would still be able to finish cultivating industrial hemp consistent with the terms of that registration. The Ordinance would deem the cultivation of industrial hemp in violation of the Ordinance a public nuisance that is enforceable under existing provisions of the County Board of Supervisors. and will remain in effect for forty-firths vote of the County Board of Supervisors and will remain in effect for forty-fire days after adoption.
