**SUMMARY OF PROPOSED ORDINANCE
ORDINANCE NO. 5135**

This ordinance hereby amends the El Dorado County Ordinance Code Title 5- Business Taxes, Licenses and Regulations - Chapter 5.56.- Vacation Home Rentals with amendments to include clarifying updates to the code for the purpose of program implementation and introducing a cap of 900 permits total in the Tahoe Basin.

Adoption of this ordinance was heard by the Board of Supervisors on December 2, 2020. The Public Hearing was held virtually.
