Dear Supervisors, Please Choose the Modified option 3 to be laid out by FOTR and RTF in their presentation for Route designation for the Rubicon Trail

It's not costing the county taxpayers a dime - all funds come from grants via OHMVR and the Volunteer Hours are a HUGE part of OHMVR granting those funds. The County is not allowed to spend General Fund Dollars on the Trail.

If you make the users unhappy by choosing a single trail option, you will loose volunteers, their hours, and maybe even the funding that goes along with that. So in reality, the cheapest option is to keep the user/volunteers happy!!!

The CAO only asks for the trail to be defined, to develop a long term plan, to do a saturated soil report, and to fix what needs to be fixed. Most of the bypasses according to CGS are not a source of sediment, and I said most, not all. But the point is, that there is more work to be done on the trail itself that there is work to be done on the bypasses. The users have proven they are willing and able to perform the work in cooperation with the County and the

USFS.
