To: Clerk of the Board of Supervisors

Dear Board Members:

On January 4, 2021 I wrote to oppose the nomination of Mr. Chris Cockrell to the Veterans Affairs Commission ("Commission"). I am writing again to update and reemphasize my opposition to his nomination as an unsuitable candidate for the commission. I urge you to remove his nomination from the consent calendar and soundly reject his approval for a public commission for the following reasons.

In short, Mr. Cockrell's undisputed disparagement of all citizens that he identifies as "Democrats" or "Progressives" is offensive to the general public good and should be disqualifying in and of itself. These views are wholly incompatible with the commission's duties, which include the public promotion of veterans affairs and recruitment to our Armed Forces. Those forces are diverse, and all eligible citizens who desire to serve should be welcomed. Those diverse citizens who have served should also be welcomed and included. Mr. Cockrell's explicit disparagement of whole categories of citizens is at odds with the commission's purposes to recruit, retain, and support ALL. Instead, he views most citizens with disdain.

Furthermore, there is undisputed evidence that Mr. Cockrell follows the Proud Boys, not only locally, but nationally and internationally. (See attached Parler records.) Just today the Canadian government declared the Proud Boys to be a terrorist organization, and two more Proud Boys members were arrested for their attack upon the U.S. Capitol on January 6, 2021. <https://www.usatoday.com/story/news/world/2021/02/03/canada-declares-proud-boys-terrorist-organization/4372307001/>

Mr. Cockrell's apparent association with these groups should be unilaterally condemned by the Board, at the same time his nomination is unilaterally rejected. There should be a bright line between this Board and groups like the Proud Boys. Condoning any link between them and candidates for the Board's approval risks giving the appearance of the Board's imprimatur of those groups, which is incompatible with responsible civic responsibilities and governance.

**Nomination and Qualifications:** My January 4th letter described conditions for appointing members to the commission. Upon further review, Mr. Cockrell's self-application (see attached) is at odds with the commission's establishing ordinance. Sections 2.25.020(A)-(B) state that voting members and alternative non-voting members may be nominated by a supervisor, "all of whom may be selected *from nominees submitted by the recognized veteran's organizations of the county.*" (emphasis added.)

I believe a plain language reading of the ordinance means Mr. Cockrell's nomination must be rejected for non-conformance with the ordinance's appointment conditions. He submitted his own application the day prior to the Board's prior consideration, and there is no evidence otherwise that I'm aware of. The facts of his nomination should be included on the record, along with the lack of any organizational endorsement per the ordinance, and his nomination rejected on that basis.

I also recommend the Board undertake a review of the current nominating process to eliminate ambiguous language, develop objective qualifying criteria, and ensure adherence to its nominating processes. For example, the establishing ordinance and the commission's bylaws contain no qualifying standards. It would appear a nominee could include persons who never served in the Armed Forces, or have no connection to veteran's services. I personally don't believe this County meant to establish a veteran's commission and then approve members without relevant experience to fulfill the commission's duties. As another example, neither document defines what the "recognized veteran's organizations of the county" are. Finally, why did Mr. Cockrell's nomination proceed to a vote without conforming to the board's requirements for appointment? Why wasn't it administratively rejected beforehand?

I am willing to submit a proposal for an objective set of qualifications to improve the current nominating process. These would serve the Board's purposes by establishing the desired standards for veteran's commission eligibility, allow consideration of the most suitable candidates as measured against those criteria, eliminate unsuitable candidates, and ensure conformity to the governing ordinance. In my view, a public commission should have SOME level of documented qualification, and in the case of a veteran's commission, those qualifications should reasonably be connected to valid military service.

My relevant background includes 25 years of service in the U.S. Coast Guard and a Masters Degree in Organization Development, assisting organizations with facilitative processes and tools to navigate change. Those include a systemic view of organizational systems. I can draft a comprehensive proposal rather quickly and would gladly offer recommendations to the Board for its consideration.

**Communications and Character:** My January 4th letter described Mr. Cockrell's open disparagement of "Progressives" and "Democrats" on his Facebook accounts. As of today (Feb. 3, 2021), Mr. Cockrell's Facebook account has been scrubbed clean (or publicly blocked) of those views. His public page has only three administrative posts: (1) a 2017 update of his biography, which simply lists his business name and address; (2) a December, 2020 cover

photo update of a Santa dressed in American flag attire, saluting an American flag; and (3) a January 15, 2021 cover photo update showing a field of American flags and the line "Freedom isn't Free." (See <https://www.facebook.com/1chriscockrell>). His political account is not available or may have been removed. (See <https://www.facebook.com/ForABetterEIDoradoCounty>).

These account differences demonstrate even more inappropriate character by Mr. Cockrell for the veteran's commission. They show me Mr. Cockrell may be: (a) unable to face public scrutiny; (b) hiding unsuitable behavior from the public; or (c) attempting to "cleanse" his previously disparaging history. None of these behaviors or motives are suitable for his nomination, nor the Board's consideration.

I would strongly encourage the Board to ask Mr. Cockrell some plain questions for the record. In particular: (1) why his accounts have changed; (2) if he is willing to make public all of his comments, in light of wanting to serve on a public commission; and (3) if he refutes his previous disparaging remarks. More directly and to the point, the Board should ask, "Why should we vote for your placement on a public commission when you have a history of publicly disparaging others based on their political party or progressive outlook, and considering you have an apparent affiliation with the Proud Boys?" I'm asking the board to ask these questions on behalf of me and other citizens who object to Mr. Cockrell's nomination, for you to judge his demeanor, character, and suitability for an important public commission.

**Parler and Proud Boys:** Just two days after I wrote my previous letter, an insurrectionist mob stormed the U.S. Capitol to protest and attempt to overturn national election results. News reports have documented that many thousands of those who participated shared their actions, and their anti-government views, on the website Parler.

I have learned that Mr. Cockrell had a Parler account, which he appears to have created on November 8, 2020. A copy of some screenshots from that account are attached, but the full extent of his Parler activities are unknown at this time. Disturbingly, those pages appear to show Mr. Cockrell was following the group "Proud Boys Hangtown - Placerville El Dorado County," which was apparently being followed by over 60 other "Proud Boys" accounts. My previous letter commented on Mr. Cockrell's apparent recognition and comfort with this recognized hate group. Now, it appears he is a follower of that group and its ideology, and was already a follower at the time of the Proud Boys/Toys for Tots controversy last December.

I understand Mr. Cockrell spoke to the Board on January 5th, but I have not been able to view his comments. However, in judgment of his suitability for the veteran's commission, I would focus on whether he refuted any such affiliations, apologized for any inappropriate appearances, or demonstrated a greater good for the community by withdrawing his nomination. To my knowledge, he has done none of those things, either to the Board or in the form of a public statement. As I mentioned in my previous letter, his public character in these regards is woefully inadequate to be considered and approved for service on a public commission representing this county's veteran affairs.

**Conclusion:** Mr. Cockrell's *explicit* disparagement of his fellow citizens and his subsequent removal of those comments from public scrutiny demonstrate poor military and civic leadership that the Board should rightly recognize as unsuitable for its veteran's commission. I am aware the Board has an agenda item to compel *Implicit* Bias training for all appointees, but that is not the solution to Mr. Cockrell's **already explicit** beliefs. He's a grown man, veteran, and business owner who should not need to be told how to treat others with respect. The Board should recognize his divisive views are better addressed by other means, not as an unfortunate personal issue that it has to contend with should he be approved. He should not.

Mr. Cockrell's hidden and unacknowledged association with a national hate group, and now an internationally recognized terrorist organization, is incompatible with the oath that military members take to support and defend our Constitution. That association is also incompatible with standards of responsible governance that this Board should require of all county appointed persons. Approval of Mr. Cockrell's nomination in the face of the record before the Board, and the opposition of many other citizens, would ultimately dishonor the commission, the Board, this County, and their reputations among their peers. Standing up for civility, and demanding the best from its commission nominees, is a straightforward path without shame. Supporting an explicitly divisive candidate and his personal ideology is not something to be proud of.

Mr. Cockrell is not the right candidate for the veteran's commission, for the reasons I and others have shared with you. Nor is this the time to overlook serious questions about his associations and behaviors, in light of daily revelations about the seditious coordination of Proud Boys groups and others throughout the country. Parler data is being made more accessible every day, and it's geographically identifiable; that is, you will be able to see videos and pictures posted in our County and anywhere else they were uploaded. Undoubtedly, more disparaging information may come to light.

Therefore, I respectfully request the Board unilaterally reject Mr. Cockrell's nomination at a minimum, with explicit documentation of his unsuitability as a matter of record. Mr. Cockrell has sought a public position, and he should be accountable by and to the public in that process. In my view, particularly as a military retiree, he has no business conducting any County business, especially in matters of military affairs.

I am opposed to the appointment of Chris Cockrell to the Veterans Affairs Commission. On December 5, 2020, Chris Cockrell dressed up as Santa and with a group identified as the "Hangtown Proud Boys" displayed a white power hand gesture in downtown Placerville. This is offensive and dangerous behavior that should be condemned.

Since this time Mr. Cockrell has NOT denounced the Proud Boys NOR has he denied that he is a member of the organization. There is ample evidence that Mr. Cockrell follows the Proud Boys both locally and nationally. Mr. Cockrell's association with the Proud Boys should be swiftly and unanimously condemned by the board. The Proud Boys have been identified as one of the players in the January 6, 2021 insurrection at the U. S. Capitol. Because of the violent and extremist nature of the group, the Proud Boys have been added to Canada's list of terrorist organizations. NO ONE affiliated with the Proud Boys should be considered for ANY appointment to ANY county seat.

Perhaps even more concerning is the Board of Supervisor's attempt to suppress public participation in governance.
