### CITY OF PLACERVILLE POLICE DEPARTMENT – VEHICLE REPLACEMENT (Tesla 3 to Replace Gas-Powered Jeep Liberty)

### **Funding Request**

The City Of Placerville Police Dept. – Vehicle Replacement (Project) would replace a Jeep Liberty gas-powered vehicle. The Jeep Liberty has a remaining useful life of 5-7 years. Eligible emissions reductions for the first 6 years are the difference in emissions between the Jeep Liberty and Tesla 3.

#### Goal

• Supplement the Placerville Police Department's low emission vehicles while helping to eliminate mobile source emissions in the region. Further promote green technology and improve credentials of local authorities.

#### **Model Inputs and Assumptions**

- Jeep Liberty 5 year life, 12 year project life sounds reasonable
- 10,000 miles per year
- Accepted the Jeep Liberty/Light-Duty emissions used

### **Cost Effectiveness Calculation**

- Cost Effectiveness was determined for the DMV funding and Total Project amount for the 12-yr project life. The Cost Effectiveness averaged over the 12 year life of the project was;
  - Years 1-12: 5 lbs emissions reduced/year = 60 lbs

### AB 2766 Grant Applications Ranking Discussion and Justification FY 21/22

- Cost Recovery Factor  $(1+i)^{n}(i)/{(1+i)^{n}-1}$  where (i) discount rate = 3% and (n) project life = 12 years. CRF = 0.1005
- Cost Effectiveness: Cost per lb = (CRF)(Cost)/Annual ave lbs reduced, so

0.1005(\$36,800)/5 lb/yr = \$739.68 /lb AQMD Funds 0.1005(\$46,000)/5 lb/yr = \$924.60 /lb Total project cost

- Vehicle EF's came from Table 3.
- Points awarded for DMV = 20 and Total Project Cost Effectiveness = 20.
