Mosquito Bridge Replacement Project Re: Support Federal Funding for Fire Safety for Your Citizens

Dear Board of Supervisors:

"The chief purpose of government is to protect life. Abandon that and you have abandoned all." ~ Thomas Jefferson

This is an appeal to lock-in and confirm upcoming funding for the Mosquito Bridge Replacement Project (Project) as it is imperative for the safety of our community and to the economic wellbeing of El Dorado County. This is the **THIRD** attempt by the El Dorado County Board of Supervisors to secure a replacement bridge for this community. Excessive time spent by government officials and community members and millions of tax payer dollars expended and wasted over decades for this Project -- still nothing to show for it. As the current Mosquito Bridge is designated unsafe by standards set by state and federal governments, it is imperative the replacement structure move forward as quickly as possible. One hundred percent (100%) federally funded, this Project will be reimbursed to El Dorado County and more importantly, your tax-paying citizens will be safer.

The Paradise Fire (aka "Camp Fire") and the deaths (which occurred during this event) was one of the most expensive natural disasters in the world. Removing toxic debris alone cost their county, and our state, and federal governments nearly \$2 billion. Victims of this catastrophic fire were unable to escape due to lack of reliable roadways and gridlock, which occurred

during evacuations. Their elected officials were careless and reckless regarding their citizens' safety, and not cognizant of the dangers in that community.

This Project will at least create a safer route to evacuate and at the same time allow firefighters, engines, and ambulances to enter as deadly switchbacks would be eliminated by the new Mosquito roadway. Presently, the only other route available is Rock Creek Road, which is also unsafe and unreliable due to rockslides and eroding roadways on the cliff side with major dropoffs to the American River Canyon. As stated so succinctly in the Mountain Democrat on May 10, 2015, concerning the present Mosquito Bridge:

On average, Mosquito Bridge is used in about 1,400 trips a day by people coming and going from the Mosquito-Swansboro area. The county spends about \$75,000 on annual maintenance while the bridge and its environs have a 32 percent higher accident rate than comparable roads.... (This is largely due to the switchbacks of the present antiquated and unsafe Mosquito Road and Bridge; these switchbacks would be eliminated with completion of the Project allowing safety vehicles to enter and citizens to more safely evacuate in case of fire or other natural disasters.)

Of the county's 79 bridges, 22 are scored above 80 on a 100-point scale used by the Federal Highway Administration, which operates bridge safety and bridge building programs.... Thirty-eight local bridges rank between 50 and 80 now. The below-50 cohort includes 17 county bridges. Mosquito has a rating of 12, second only to the Mt. Murphy Bridge in Coloma, which ranks below zero... Mosquito was a 3 prior to its most recent repairing and re-planking....

The FHWA bridge funding program will cover 100 percent of bridge replacement for "off-system" bridges, typically small, rural ones.... "23 percent of our bridges are eligible for replacement." The program funds about \$300 million for bridges annually.

As concerned individuals lament about "no-growth" platforms in our county, please know that Swansboro is allowed to sell only two-acre lots. The majority of those lots are already committed and sold. Building permits continue to be issued by El Dorado County in this area, and young families are moving in who deserve a safer community for their children and their school bus, which currently takes Rock Creek Road; this road is a disaster waiting to happen.

We understand your votes are influenced by "no-growth" and "recreational" special interest groups (aka lobbyists) in this county who fund your campaigns and influence your votes. We are asking you put aside your bias and look-out for the well-being of the community and its tax-payers. It is inexplicable why El Dorado County would not confirm and vote for federal funding for this Project and its community for its citizens' safety. The new high-rise bridge would ultimately save money annually and generate more tax dollars to this county by its citizens.

Mosquito Road is a patchwork of repaired asphalt sections dotted with pot holes and endless fill patches. The entire road surface is falling apart with large sections of asphalt being uprooted by the constant increase in vehicle traffic.

Building the new bridge will allow heavier vehicles and more traffic to travel over a road surface that was never engineered to accommodate current traffic levels. UNLESS EL DORADO COUNTY HAS FUNDING AND PLANNING IN PLACE TO WIDEN AND REPAIR MOSQUITO ROAD, THE CONSTRUCTION OF A NEW BRIDGE WILL BE NOTHING MORE THAN A FOOLS ERRAND!!!!!!

There are already dangerous levels of traffic on Mosquito road. The current wooden bridge gets damaged on a regular basis because large trucks (Some towing trailers) refuse to recognize and obey load weight and vehicle maximum length notification signs. This will only get much worse when a new bridge is built. El Dorado Road Maintenance states that they cannot deny access to commercial vehicles on public roads. 

(PLACERVILLE) – On February 9th, 2021, El Dorado County Department of Transportation will submit to the Board of Supervisors a High Cost Project Agreement that will secure full construction phase funding for the Mosquito Road Bridge at South Fork American River - Bridge Replacement Project (Project).

This Agreement secures the Highway Bridge Program construction financing plan with the California Department of Transportation and the Federal Highway Administration. In 2011, the Project was awarded Federal Highway Bridge Program funding to start the project environmental and engineering work. After years of study, design, community meetings, public outreach, environmental clearance, and utility coordination, the Project is finally fully funded and scheduled to break ground with construction next year. The existing one-lane suspension bridge still requires annual closures for maintenance work and has the most expensive maintenance costs of all the County's vehicle bridges.

Once the Agreement is approved, Transportation will be finalizing the construction bid package and advertising the Project for bids. Construction activity is anticipated to begin in mid-2022. After the new bridge is

complete, the existing 1939 suspension bridge and roadway is planned to remain in place for cyclists, pedestrians, and river access.

PRIOR BOARD ACTION

On August 16, 2016, Item 25, Legistar 16-0629, the Board adopted the Draft Feasibility Study for Public Access to the South Fork of the American River at Mosquito Road Bridge.

On August 8, 2017, Item 27, Legistar 17-0725, the Board certified the Final Environmental Impact Report.

On December 10, 2019, Item 47, Legistar 19-1702, the Board received a presentation regarding the latest Project design and adopted the Addendum to the Final Environmental Impact Report.

FINANCIAL IMPACT

Funding for the Project is included in Transportation's 2020 Capital Improvement Program, which was approved by the Board on June 9, 2020, Legistar 20-0675, Item 54 and consists of 100% HBP Federal funds. The construction phase of the Project is anticipated to be Advance Construction (AC) funded through various local funding sources over the multi-year Project and will be outlined in the request for authorization of advertisement of this phase in a future Board item. Any negative interest charges accrued as a result of timing of reimbursements will be covered with Public Utility Franchise Fees.


