




Employee Survey Results

Current State:

Recommended Next Steps

OPTION 1:

- 1. Conduct a formal bid not specifying the productivity tool. Estimated 4-5 months
- 2. IT to gain approval from the board based on recommendation

RISK: Ability to meet timeline to decommission prior to contract expiration:

Google expires 02/2022

Microsoft expires 08/2021

IMPACT: Cost increases to extending contract, no guaranteed rate. Cost will increase.

PROBABILITY: High

OPTION 2 (recommended):

- 1. Gain Board of Supervisors approval today to start planning activities to migrate from Google to Microsoft
- 2. Begin procurement activities to fully migrate by February 2022
- 3. Upon completion of the solicitation, return to Board for Approval to proceed
