
FUNCTIONS

- Provide a forum for interagency cooperation and coordination in the prevention, detection, intervention, treatment, and legal processing of child abuse cases
- Promote the public awareness of abuse and neglect and the resources available
- Encourage and facilitate training of professionals in the prevention, detection, intervention, treatment, and legal processing of child abuse and neglect
- Recommend improvements in services to families and victims
- > Encourage and facilitate community support for child abuse and neglect programs
- Serve as County Children's Trust Fund Commission
- > Provide input for the County's CBFRS, CAPIT and FSSP Plans.


Substantiated Cases of Child Abuse: 1998 - 2008

Substantiated Cases of Child Abuse, by Age: 2008


El Dorado County: Percent


Substantiated Cases of Child Abuse, by Type of Abuse: 2008

El Dorado County: Percent




Definition: Percent distribution of substantiated cases of child abuse for children under age 18, by type of abuse (e.g. 9.1% of substantiated cases of child abuse in California in 2008 were physical abuse).

Number of Children in Foster Care: 1998 - 2008



Definition: Number of children under age 21 in foster care as of July 1 of each year.

Re-entries into Foster Care: 1998 - 2007



Definition: Percentage of children under age 18 discharged from foster care to reunification during the year who reentered foster care less than 12 months from the date of discharge.

- Increase access to substance abuse treatment
- Increase access to mental health services
