The only structure I know of that approaches this project of "so much for so few" is the Forest Hill bridge which, if not for the then planned dam, would not exist today for a seemingly larger population.

Cultivation of Cannabis for Personal Use

Update to Board of Supervisors February 23, 2021 at 11:00 am

Planning and Building Department, Code Enforcement Division, recommending the Board receive an update on the implementation and enforcement of Ordinance 5122, Cultivation of Cannabis for Personal Use.

Background

On May 5, 2020, the Board adopted Ordinance 5122 to simplify standards for the cultivation of cannabis plants for personal use and to make the County's allowance of the amount of cannabis cultivated for personal use more consistent with other counties throughout the state. The ordinance is now codified at Chapter 130.42.00 of the County Code. The ordinance was also one step in assisting law enforcement in their efforts to reduce the pervasive illegal grows by organized crime in the County that are supplying the black market and enabling Code Enforcement to more efficiently and safely enforce more minor violations.

The ordinance now allows for a maximum of six (6) cannabis plants per residence, with a maximum of six (6) plants cultivated outdoors per parcel. For a parcel with more than one legal residence, an additional 6 plants per residence are allowed indoors only. Outdoor cultivation is allowed within a greenhouse, hoop-house, hothouse, glass house, conservatory, or other similar structure, provided they comply with all building and zoning codes. Consistent with the prior ordinance, cannabis plants must be screened from view from adjacent streets or parcels and must employ security measures including six-foot high fences secured with locks. In addition to meeting property line setbacks (50 - 100 feet, depending on zoning) all cannabis cultivation must be at least 1,000 feet from sensitive uses, including: schools, school bus stops, churches or places of worship, parks, child care centers, or youth-oriented facilities. Finally, all cannabis cultivation is subject to strict odor control protocols, violation of which may lead to Code Enforcement action taken to mitigate odors escaping a subject property.

Dear Governor Newsom,

We heard your press announcement on Monday, in which you outlined your efforts to streamline and broaden COVID vaccine distribution, with deep interest. Among the various high-priority groups, you made particular mention of seniors and of the importance of administering vaccine to them as soon as possible and in the greatest possible numbers.

You committed yesterday to ensuring that vaccine goes to disproportionately impacted communities. El Dorado County has a per capita senior population well above California's as a whole, thus our eagerness to benefit from the State's plans to simplify and standardize vaccine delivery and speed the pace of vaccinations. More specifically, El Dorado County has a total population of approximately 190,000, more than 40,000 of whom are senior citizens, yet to date we have only received 16,700 doses of vaccines.

Our County's population is about four-tenths of the State's, yet we have to date received only about three-tenths of the State's vaccine allotment, averaging 2,800 doses per week. We are very proud to report that every dose received has been administered or scheduled to be. In addition, El Dorado County has the benefit of having a well-qualified cohort of public health nurses, hospital staff, paramedics and others standing by to administer vaccines to the senior population and those in Phase 1a and Phase 1b tier 1 as soon as the needed vaccines are available.

You have emphasized the importance of vaccine distribution in the State's dealings with the federal government. In that spirit, we ask and urge you to include El Dorado County among priority destinations for increased vaccine delivery in California.
