I recently read an article in the El Dorado Hill's Village Life about a proposed new cell tower to be installed at the Oak Ridge High School football field (https://www.villagelife.com/news/cell-tower-in-the-works/). I am alarmed about having a cell tower in such close proximity to the students and staff at Oak Ridge and nearby Rolling Hills Middle School. Health risks like cancer are associated with close, frequent exposure to radio frequency (RF) radiation. I have done some online research on this topic and believe this project should not be approved.
