- A drop-in center that operates during normal business hours to assist victims of domestic violence who have a need for support services.
- Arrangements for school age children to continue their education during their state at the domestic violence shelter-based program.
- Emergency transportation as feasible.

In accordance with Section 18295, to the extent possible, and in conjunction with already existing community services, the domestic violence shelter-based program shall also provide a method of obtaining medical care, legal assistance, psychological support and counseling, and information regarding other available social services.

<p>There were 903 individuals were provided domestic violence services. 84.93% were between the ages of 25 - 64. 3.98% were under 18; 6.79% were between the ages of 18-24. 4.28% were over 64 years of age. 73% identified as of Caucasian decent. 15% identified as Hispanic. 25% declined to state a racial identity. The remaining 12% of clients identified as Native American, African American, Pacific Islander, Asian, or Other. 90% of clients identified as female, 9.65% identified as male, and .25% identified as other. When asked to report a monthly income, 67% made less than \$20,000 a year, and 33% made more than \$20,000 a year.</p>
