

AGREEMENT FOR SERVICES #4097
AMENDMENT I

This Amendment I to that Agreement for Services #4097, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and KP Research Services, Inc., a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 11818 Kemper Road, Auburn, CA 95603; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide detailed pre-employment background investigations for candidates for employment with the Sheriff's Office and Probation Department on an "as requested" basis, in accordance with Agreement for Services #4097, dated August 7, 2019, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase compensation of said Agreement, hereby removing and replacing the third paragraph of **ARTICLE III Compensation for Services**; and

WHEREAS, the parties hereto have mutually agreed to update **ARTICLE XII Notice to Parties**.

WHEREAS, **ARTICLE XXV Administrator** shall be updated by replacing it in its entirety.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #4097 shall be amended a first time as follows:

1. **ARTICLE III Compensation for Services** shall be amended by deleting the third paragraph in its entirety and replacing it as follows:

ARTICLE III

Compensation for Services:

Total amount of this Agreement shall not exceed \$140,000.

2. **ARTICLE XII Notice to Parties** shall be amended in its entirety to read as follows:


