Greetings,

I am the owner of APN 331-090-01, a 6 acre parcel that borders the Shinn Ranch, and I strongly oppose the renewal of the dense housing plan to above identified development project.

I have lived in my home for 20+ years and moved here for the country life. In that time, I have seen the traffic and noise increase and the wildlife decrease tremendously. In the beginning I use to hear large families of coyotes yapping on the north and west sides of my property. Now I hear an occasional coyote, but mostly roaring trucks and motorcycles from nearby Pleasant Valley and Mother Lode roads. The noise will get exponentially worse with hundreds of more vehicles on nearby roads.

The noise is unpleasant to be sure, but more people and vehicles worries me if there is a fire. The Bumper Fire a few years back had me on the verge of evacuation. I can't even imagine if my existing neighbors AND a new development with one road in and out all had to evacuate at the same time! It would be a disaster!

The Morris property to the north of me (APN 331-007-02) has to be a large nesting space for hawks as well. I frequently hear a cacophony of fledglings still in their nest every spring. And owls! They must nest nearby as I've seen the babies learning to fly. Have any studies been done on the impact to the wildlife that still may be using the surrounding parcels and the Shinn Ranch to procreate? I understand that this project has been in the development since 2004, but I an certain these animals are still nesting nearby. I urge the Commission to consider the wildlife not just because I love it, but because it is the right thing to do.

I am also concerned about rattlesnakes. I don't see them now, although I know they are there. What will happen to my property when the rattlesnakes get pushed out during a development? My property will be overrun most likely.
