Dear Supervisors:

There seems to be a recent pattern of nominations of people from a defined political perspective to county commissions.

This, of course, is to be expected, given the way our political system works...but it seems to me to be problematic in these cases, as proponents from this group advocate prioritizing personal freedom over the general public good. One of the ways they express this impulse is to try to undermine and tear down established government structures, including challenging public health directives and proposing recalls of politicians who "misbehave." All of this is within their rights.

....But I don't see the wisdom of appointing folks of such views to positions of public service, as their perspective actually emphasizes individual freedom over the well-being of the community at large. Does this stance infringe on their right to free speech? I don't think so: there is a difference between speech and action. We in this country are promised the right to express our views through speech to the government.

But I don't think a government body like a commission, which is tasked to a defined mission, is compelled to include folks whose actions have been antithetical to the task of that commission. In the current instance, regarding a proposed appointment to the Commission on Aging, refusing public health guidances, insisting on gathering in public maskless, and refusing vaccination against Covid-19 are actions which are contrary to the health and well-being of the aged community.

I'm not a lawyer. This just seems like common sense to me.

I request that Item 11 be pulled from the consent calendar for discussion on April 20th, 2021.

I'm sure you're getting tired of getting my and other's letters regarding boards/commissions/committees..

Speaking for myself, I'm not too excited about continuing to write them.

I'm concerned about folks who are not highly qualified being recommended for various commissions. These people I'm sure are great at doing other things, but these positions need people with a depth of related life experiences to make these commissions effective.

Why are we going through this, repeatedly? It's not that those who oppose these recommendations are "out to get" a particular group of people, as it's been suggested. Nor are we "out to get" a particular Supervisor. I don't oppose any specific type of ideology, unless it conflicts with the purpose of the commission. I think a "conservative" person with appropriate experience and co-operative demeanor would be a great candidate.

Since much of the business of the Commission on Aging is elder health related, I'd like to see someone with science based beliefs that supports health programs, and not oppose them. I also wonder how an antigovernmental person, on both the local and state level, would work in a cooperative way with the Board of Supervisors, which is a government entity itself. Just a question, not an accusation.

When I look at the applications that some candidates submit, specifically the portion that addresses their qualifications for the position, and compare it to the bylaws and mission statement of the commission, sometimes I see little overlap.

Regarding the **Commission on Aging**, having older relatives is not a strong qualifier for this position. I'd like to see that an applicant has provided hands on assistance to the older population, and/or has done volunteer work in this area, or has related work experience. I'd like to see something that demonstrates compassion and care for elders.

#### Subj: Keeley Link nomination to Commission on Aging

Dear Board of Supervisors:

I am writing to voice my opposition to Ms. Keeley Link as a commissioner of the Commission on Aging. The Commission's purpose includes to "work on community interests and issues faced by seniors in El Dorado County." Ms. Link's public comments that openly disparage public health efforts to reduce the spread and effects of COVID-19 are the most problematic issues regarding her nomination. So too is her promotion of groups that don't believe in the value of government, of violence and violent symbols, and her general intolerance of groups outside her own. These views are documented below for your information.

Secondly, I continue to object to the County's current process for selecting and nominating commissioners, an issue I've addressed to you before. This nomination marks the fourth nomination in a row by Supervisor Turnboo to promote candidates with openly divisive speech and views. Myself and others have documented those views to you *after their nomination*, rather than having them screened in advance by an objective Human Resources driven process. These divisive nominees are then placed on your "consent" calendar as an expectation of approval, rather than following a rigorous process to nominate the best candidate who is the most qualified, and who has been subject to public input--all for your review and consideration. I ask, again, that you direct the Chief Administrative Officer to review the current process and recommend significant improvements. I have offered to help in that regard and my offer stands, as someone with experience in facilitating organizational change.

#### **Disparagement of Public Health Efforts:**

Senior citizens, like myself, have an expectation of good health and happiness. Among the threats to our health is COVID-19, as seen on the Commission's partners websites. For example, "The Administration for Community Living was created around the fundamental principle that older adults and people of all ages with disabilities should be able to live where they choose, with the people they choose, and with the ability to participate fully in their communities." (See <a href="https://acl.gov/">https://acl.gov/</a>.) Among its "Top Stories" are "CDC Issues COVID-19 Guidance for Day Centers Serving Adults with Disabilities," and "ACL's COVID-19 Resources: What's New." (See <a href="https://acl.gov/news">https://acl.gov/</a>.) As another example, the California Department of Aging's homepage shows seniors wearing masks, and features two links to COVID-19, titled "COVID-19 Information and Resources," and "Californian Lives Lost to COVID-19." (See <a href="https://www.aging.ca.gov/">https://www.aging.ca.gov/</a>; Figure 1.)

These health precautions, and the health risks of COVID-19 exposure, are important personal issues to me. I am a heart bypass patient, and while in good health, I remain vigilant about protecting my personal health. More importantly, I consider the health of others in the midst of

this pandemic, and I wear a mask for the benefit of all citizens, *including* Ms. Link and her family. It is not an inconvenience for me to do so, but she sees these public health efforts as "tyranny."


Figure 2 Keeley Link Profile Picture "El Dorado County Freedom Fighters" October 24, 2020

Ms. Link is the sole moderator of a public Facebook page titled "El Dorado County Freedom Fighters," a "Community Organization" followed by 896 persons. Her profile picture shows her holding a sign that says "TAKE OFF THE [image of mask] SMELL THE BULL\$HIT" in the foreground of a larger picture of a protest she organized against the County's Public Health Officer, Governor Newsom, masks, and vaccines. Both images were originally posted on October 24, 2020. (Figures 2-4.)

The public protest against COVID-19 mitigation efforts was one of several that are shown on Ms. Link's Facebook page, dating back to her original post of October 24, 2020. The caption of the protest photograph includes, "It was one of 20 protests that took place across California and in six other states, organized by the Freedom Angels Foundation. The Freedom Angels Foundation is an anti-vaccination group initially formed to counter 2019 vaccination laws in California that now aims to bring change to COVID-19 public health measures."<sup>1</sup>







When Ms. Link began her Facebook page on or about October 24, 2020 the cumulative deaths from COVID-19 in the United States were **225,674** persons. (Figure 5.) As of the date of this letter **563,980** persons have died and that number continues to grow. (Figure 6.) Deaths among older persons in the United States, who Ms. Link desires to support, have been disproportionately affected by COVID-19. (Figure 7.)<sup>2</sup>









Figure 10 Keeley Link, Leader of El Dorado County Freedom Angels September, 2020

Ms. Link has been identified as the "leader of the El Dorado County offshoot of the Freedom Angels Foundation." (Figure 10.)<sup>5</sup>




Figure 13 Dismissal of Vaccination Benefits Figure 14 "Communist Coercive Methods"

That event made the national news when another of Supervisor Turnboo's commission nominees, Mr. Chris Cockrell, posed as Santa Claus with the Hangtown Proud Boys at the Bell Tower, flashing the group's divisive "OK" sign.




Figure 17 "Preserve the Noose" Rally April 14, 2021

The Hangtown Proud Boys ("HPB") have recently appeared in Placerville again to protest the removal of a noose from the City of Placerville logo, on April 9 and April 16. On April 13 the City Council voted 5-0 to remove the noose symbol, after hearing hours of public comment and considering additional written comment. Ms. Link posted a notice to protest that vote and urged the public to vote out the entire City Council (Figure 17), while advocating for the display of a hanging effigy on Placerville's Main Street. (Figure 18.)

A disturbing connection between Ms. Link, the Hangtown Proud Boys, and the City Council's vote is the display of a noose. The HPB's clothing includes a person hanging from a noose. (Figures 19-20.)




Figure 18 Promoting History of Hanging April 17, 2021

#### Conclusion: Reject Ms. Link as Commissioner to the Commission on Aging

Ms. Link's persistent efforts to discredit public health efforts that are meant to save lives is an appalling history of insensitivity, and a great personal insult, to every person who died because of COVID-19, the suffering of their families, and all those who endeavor to save more lives from a dangerous pandemic. So too is her nomination.

Her views show contempt for government and for the majority of the public who looks out for one another with compassion and concern. Our Government, while not perfect, is something that does strive for a "more perfect Union," but Ms. Link and her supporters selfishly demand "freedom" rather than offering selfless service to all.

Even more appalling is Ms. Link's direct connection to the "Mamalitia" group, formed from their mutual anti-vaccination views, her support of a noose as a government symbol, and support of groups that include the Hangtown Proud Boys, who promote death by hanging on their clothing.

Her nomination is an affront to civic decency and good governance. Her endorsement by the Board of Supervisors would signal approval of her outlying views and lack of civility amongst responsible commissioners on an important commission.

The Board should reject Ms. Link's nomination and expect a more qualified, less divisive candidate for the Commission on Aging. There are bound to be more suitable candidates among this County's citizens who actually promote the commission's programs, including the emotional and physical health of our older citizens.
