Dear Chairman Veerkamp & County Supervisors,

Thank you so much for discussing re-opening our local economy today.

Our membership has been personally damaged by the current economic shutdown that is taking place in El Dorado County and throughout the State of California. Our friends and neighbors are losing their jobs, the ability to pay their mortgages, and the financial resources that it takes to put food on the table. Deeming the vast majority of industries as non-essential has also taken away the self-respect and dignity of many.

Our Party completely agrees with the resolution from Placer County attached to this item and respectfully asks that you send something to the Governor immediately. Local business owners and hard-working families have always been relied upon and expected by government to pay their taxes. These same people are completely capable of re-opening our local economy in an expedited and responsible manner.

Pertaining to the Governor's recent threat to Yuba, Sutter, and Modoc counties in regards to cutting off certain types of state funding, if they do not comply with his orders; this is an overstep of his authority and directly highlights the ineptness of large bureaucratic government. For too long, the people of this community and the State of California have seen the Governor and the State Legislature literally throw money away. We have seen high-ranking government

officials use our hard-earned money in a manner that is reflective of a game of Monopoly. These same irresponsible and so-called 'leaders' are now to be assumed experts at handling a pandemic and re-opening our economy. Remember, not long ago these same leaders had us sitting in the dark, because they couldn't get PG & E to keep the lights on.

Your county counsel may advise you to not follow in the path of Placer, Yuba, Sutter, and Modoc; despite this, it is imperative that you take a stand for your community. Any financial threat the state could impose on us is ridiculous, because the Governor admitted last week, the state could be taking a hit of a \$53 billion deficit.

Our Party is concerned that if our local economy doesn't re-open immediately, **the only El Dorado County casualties of COVID-19 will be the local governments of the City of Placerville and the City of South Lake Tahoe. They rely heavily on sales tax revenue.**

Former State Assembly Speaker & Mayor of San Francisco Mayor Willie Brown sums it up well in his opinion editorial in the San Francisco Chronicle from 05-09-20:

*And trying to keep businesses from opening with threats of suspending their liquor licenses or cosmetologist licenses won't work — not on a mass scale that would be needed if many people start to say: enough. The goal of the shutdown was to curb the coronavirus and keep the hospitals from being swamped. We kept the hospitals working, but we have yet to curb the virus and a vaccine is probably at least a year away. In the meantime, we're headed over the economic cliff and facing unemployment numbers the likes of which we have never seen before.'*

Dear El Dorado County Board of Supervisors,

I am writing to plead with you to move forward in the re-opening of El Dorado County. I may not be a small business owner in the county, but I stand with them and support them wholeheartedly. We are all essential, and it is a denial of our civil rights to discriminate against small business owners while letting the Walmarts of the world go on to bank millions.

Not only is it a civil rights violation, but it is a violation of the United States' and California's Constitutions. Section I of the California Constitution clearly states, "All people are by nature free and independent and have inalienable rights... enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy."

Furthermore, the First Amendment states, "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof...or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances." Prohibiting people from going to church is a direct violation of the document which our country was founded upon.

As far as making the use of masks mandatory in public, the limited, seemingly "unbiased" science that I could find states that the use of masks may reduce the risk of coronavirus, but not significantly. According to a study posted on medRxiv, which distributes unpublished manuscripts describing health research and was founded by Cold Spring Harbor Laboratory (CSHL)—a not-for-profit research and educational institution—Yale University, and BMJ, a global healthcare knowledge provider, "The evidence is not sufficiently strong to support widespread use of facemasks as a protective measure against COVID-19." According to the study, masks are encouraged for at-risk individuals, but I believe we are adult enough to decide whether or not we fall into that category and need to take further precautionary measures. Not to mention, if masks actually worked, wouldn't we all be able to just throw on a mask and go about business as usual?

In closing, I urge you to do what is right for this county. According to an L.A. Times article, "economists at Stanford and the University of Chicago...estimated that 42% of pandemic-induced layoffs will end up being permanent." The same article stated that Newsom projects "California's 2020 unemployment rate will be 18%, compared with a peak of 12.3% during the Great Recession."
