Re: CONDUCT OF RELIGIOUS SERVICES

Dear Mayor Collin and Council Members:

I will make this communication a brief one in my appeal to you.

Places of worship within the City limits need to be allowed to open their doors for religious services if they observe safe practices in the conduct of their services. Not all religious organizations have the desire or ability to conduct these services online. Rules restricting the conduct of these services need to be removed immediately.
