To the El Dorado County Board of Supervisors:

I am concerned about what appears to be a cavalier response to the COVID-19 Pandemic by the El Dorado County leadership. I do not feel like I can trust you and others in County leadership to guide us safely through this challenging time. It is possible that I am mis-informed about some of my perceptions. Here is how it seems to me.

You as a Board pushed to reopen the county prior to it being safe to do so. We are not separate from the Sacramento region, or the Bay Area for that matter. Most workers in the County commute out of the County to work. Highway 50 is a major tourist route that brings in people from out of the county. By pushing to open early based solely on our local county numbers you put us at undue risk.

I do not see evidence of enforcement of social distancing behaviors when I have been out on essential errands. There is not universal requirements for use of masks in indoor retail space. And I have heard (yes, this is hearsay) that the El Dorado County Sheriff has declared that he and his staff are not going to enforce Public Health guidelines that are in place as part of the re-opening.

At this point, I am left with only the option of taking my purchasing power out of the County. I have always tried to support our County's sales tax base in my purchasing decisions. But if I do not feel safe to be indoors with my fellow citizens, it does not matter how you rush to reopen. I will not be buying.

This is on top of our pool in ALT being closed with no open date in site, our Folsom Lake access off Rattlesnake Bar Rd still being closed, Rec. Swim being canceled the list goes on and on as you know.

I'm not sure how much more of this you expect us to endure. I moved to the United States of America from a communist country back in 1982. As a 10 year old I remember these types of restrictions, and government control, but I never in my wildest dreams though it would come to this, in this country. Yet, here we are.

When you asked us to SIP for 2 weeks, I was all for it. Let's figure it out and see what this virus is all about. Then you came out and said 2 more weeks. Ok we need a little more time. Folsom Lake opened up to the public on May 15th in SIX different locations.

- Granite Bay in Placer County
- Beals Point in Placer County
- Nimbus Flat
- Negro Bar in Sacramento County
- Folsom Point in Sacramento County
- Brown's Ravine including the Folsom Lake Marina in Eldorado County

However, our boat access and day use area at the Peninsula off Rattle Snake Bar Rd remains closed until further notice.

This is unacceptable and I'm shocked our representatives are just sitting back letting this happen. Open the park ASAP, we need somewhere to go local, and outdoors is the best place to get a little exercise for/with the kids especially as temperatures rise.
