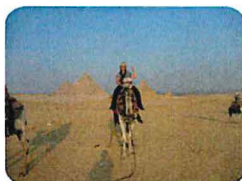
It has come apparent to myself and other EDC county residents that the State of Emergency due to Covid no longer exists. Health emergency declarations are to be terminated at the earliest possible date as condition warrant. Based on our county's extremely low Covid 19 deaths (2), zero current hospitalizations and a continuing trend of recoveries outpacing new infections, Covid is no longer a threat to the general population of this county.
