"Council members:

I am horrified and devastated by the number of Covid-19 cases in EDC, but more importantly, SLT. WE HAVE TO DO SOMETHING TO ENFORCE THE MASK MANDATE **NOW!!!** I feel very strongly that we should have *electively rolled back to the red tier* at least a month before we transitioned to the purple tier; if we had, we most likely wouldn't be in the state of crisis that we are now.

We, the residents need to feel that the council WILL DO SOMETHING to help protect our personal health, and the continued accessibility to receive urgent medical care in EDC if we need it.
