





Overall trend in cases El Dorado County






Note: >100 is ~equivalent to Purple Tier



"All individuals living in the State of California are currently ordered to stay home or at their place of residence, except for permitted work, local shopping or other permitted errands, or as otherwise authorized"




Why a stay-at-home order?

Why a stay-at-home order?


 \rightarrow More than double the summer peak


Existing orders

- Stay-at-home order (March 19 & May 4 orders plus general and industry guidelines)
- Blueprint for a safer economy (August 28 framework plus additional or revised general and industry guidelines, based on 'tiers' system)
- Limited stay-home order (November 21, for purple-tier counties, 10 pm – 5 am activity restrictions)

New: Regional stay-at-home order

5 regions

- Alpine, Amador, Butte, Colusa,
 El Dorado, Nevada,
 Placer, Plumas,
 Sacramento, Sierra,
 Sutter, Yolo, Yuba
- Regions are logical because hospitals transfer patients across county lines when necessary



Regional stay-at-home order

- Announced December 3, 2020
- Goes into effect at 11:59 PM day after a region determined by CDPH to have less than 15% staffed ICU-bed availability
 - San Joaquin Valley region (12:59 pm on Dec 6)
 - Southern California region (12:59 pm on Dec 6)
 - Bay Area (5 of 9 counties, voluntary, 12:59 pm on Dec 6 or Dec 7)

Regional stay-at-home order

When triggered, order will...

- remain in effect for at least 3 weeks
 After 3 weeks, order will...
- be lifted when a region's projected ICU capacity returns to >15%

ICU capacity projections to be assessed weekly after initial 3 weeks

Regional stay-at-home order

When regional ICU-bed availability falls <15%...

- No private gatherings of any size
- Sector operations closed except for critical infrastructure and retail
- 100% masking and physical distancing in all other sectors required
- No changes to school guidelines although state discourages counties to accept elementary school waivers if new-case rate >2x purple-tier threshold (7/100,000 per day), i.e., >14/100,000

Vaccine

Distribution - 1st shipment – Pfizer vaccine; Moderna vaccine to follow ~1 week later

- 327,000 doses to California
- ~35,000 doses to be shared locally
 - Alpine, Amador, Calaveras, El Dorado, Nevada, Placer, Sacramento, San Joaquin, Stanislaus, Tulare, Tuolumne, Yolo
- ~1000 doses for El Dorado
- Ultra-low temperature storage needed (-70 C)

Prioritization

- Healthcare workers who are likely to be exposed to COVID-19
- Residents of skilled nursing and other longterm care facilities who are at high risk of severe illness if infected with COVID-19
- Further considerations to be applied (types of healthcare being performed, healthcare worker personal risk factors, COVID-19 rates in community, and others)
