Dear Board Members,

I am writing to once again express my concern about the lack of transparency and abuse of power we are witnessing from Nancy Williams. At the latest board meeting she said the following:

"Sometimes we may actually have to infringe on some people's rights in order to protect the majority of other people's rights."

This is not how we operate in America. We are a constitutional republic, not a democracy. This means that our government exists to protect our individual rights, NOT the majority. This is a very important distinction. Nowhere in the constitution does it say that my rights can be indefinitely suspended by an unelected public health officer for the "greater good".

Statistics show that we are no longer in a pandemic. The PCR testing has proven to be unreliable, and to my knowledge we have not been given information about how these tests are being calibrated in this county. Deaths have always been low. Even if we were still in a pandemic, there is no science showing that lockdowns and masks are working. Florida is completely open, and their Covid statistics are similar to California, which has some of the most restrictive policies.

Keeping people from their livelihoods, and children out of schools is criminal. This has been done with absolutely no scientific basis, for a virus that 99% will recover from, and children rarely even get. Masks restrict our breathing, cause bacterial infections, and remove our very humanity. Making children wear them is unnecessary, and child abuse in my opinion. It says right on the box that they don't work against viruses. We have all overreacted to media fed fear and misinformation. Dear Elected Members of the El Dorado County BOS, Nancy Williams, and All Related Staff,

My name is Denise Sweeney. I reside in Diamond Springs. I work locally. If your meetings took place when most of your general constituency could attend, I am sure more of us would! As it is, I must try to make my voice heard by email in the hopes that you are honest enough in your representation of the general public to read and acknowledge my concerns publicly at your next meeting.

My concerns are many regarding your collective leadership and decision making process. My new and primary concern is now this inane conversation led by County Health Officer Nancy Williams regarding Vaccine Passports. This is a method of forced compliance to an ideal shared by some that does not meet the needs of the many. It is fear based, fear mongering at its finest. Think about what you will be doing when you step on this path. There are people out there that can not get this vaccine. People that should not. People that will not. I fall into the "will not" category. I had Covid in January of this year. There is no empirical evidence that this vaccine is warranted for a person who has acquired natural immunity by having had the virus.
