
# California SAWS Consortium IV



# County Purchase ED-01-2010 El Dorado County – Type 1 Scanners and Symbol Scanners





#### I. Overview:

El Dorado County would like to purchase thirteen Type 1 scanners and sixteen Symbol barcodescanners through the use of County funds. This purchase will also include imaging software as well as administrative charges for the asset tagging, inventory and transportation of hardware. The scope of this County Purchase includes the following:

- Hardware and Software:
  - o (13) Fujitsu FI-6130 Scanner (Type 1 Scanner)
  - o (16) Symbol LS2208 Barcode Scanner
  - o (13) ImageNow CaptureNow for Adrenaline
- Hardware and Software Support:
  - o (13) Fujitsu FI-6130 Scanner (Type 1 Scanner) 1 Year of Hardware Support
  - o (13) ImageNow CaptureNow for Adrenaline 1 Year of Software Support
- Administrative Charges

#### Assumptions:

- The Total Cost is an estimate and is subject to changes at the time of ordering. The estimate includes shipping/handling and taxes as appropriate. The final cost will be provided to the Consortium at the time of invoicing.
- New equipment will initially be sent to the warehouse in Riverside, California where
  Contractor staff will perform asset tagging and inventory. Once asset tagging and inventory
  have been completed, Contractor staff will transport the equipment to El Dorado County.
- Taxes for hardware items were estimated at 8.75% and based on the initial shipping location of Riverside, California.
- Shipping/Handling charges for hardware items were estimated at a rate of 3.0%.
- The Consortium will retain ownership of all Type 1 scanners and software licenses purchased under this County Purchase.
- Hardware and Administrative charges will be invoiced and paid in full upon receipt of hardware acceptance.
- The Administrative Charges included in this County Purchase are for the asset tagging, inventory and transportation of the hardware on this order.
- County staff will be responsible for the set-up and installation of all hardware and software on this order.
- All Fujitsu scanners are purchased with 1-year hardware support agreements from the date
  of purchase (unless noted otherwise). Once the hardware support agreements have expired,
  the County will have the option to either refresh the equipment or renew the hardware
  support agreements. If the County chooses to refresh the equipment or renew the hardware
  support agreements, then a separate County Purchase will be required.



- The County is responsible for scanner kit maintenance.
- All ImageNow software licenses are purchased with 1-year software support agreements
  from the date of purchase (unless noted otherwise). Once the software support agreements
  have expired, the County will have the option to either refresh the software or renew the
  software support agreements. If the County chooses to refresh the software or renew the
  software support agreements, then a separate County Purchase will be required.
- All Symbol Barcode scanners are purchased with 5-year manufacturer's warranties against defects in workmanship and materials from the date of purchase (unless noted otherwise).
- The County must approve this County Purchase as well as provide an approved Advance Planning Document (APD) by April 5, 2010. Otherwise, the estimates provided in this County Purchase will not be valid and a new County Purchase will be required.

#### II. Schedule:

The charges associated with this County Purchase will be incurred during State Fiscal Year 2009/10.
