OPERATIONAL AGREEMENT: FISCAL YEARS 2010-2013

This Operational Agreement stands as evidence that Womenspace Unlimited South Lake Tahoe Women's Center and the El Dorado County Department of Human Services intend to work together toward the mutual goal of providing maximum available assistance for victims of domestic violence and sexual assault who reside on the eastern slope of El Dorado County. Both agencies believe that implementation of the proposal, as described herein, will further this goal. To this end, each agency agrees to participate in the programs by coordinating / providing the following services:

South Lake Tahoe Women's Center (Women's Center) will closely coordinate the following services with the El Dorado County Department of Human Services (DHS) through:

- Women's Center project staff being readily available to DHS for service provision through in-person and telephone contact; and
- Quarterly meetings between the Women's Center Executive Director and a representative from DHS to discuss strategies, timetables and implementation of mandated services.

Specifically, South Lake Tahoe Women's Center agrees to the following:

- (1) Accept referrals and provide 24-hour availability to assist victims of domestic violence and sexual assault:
- Engage in cross-trainings with DHS staff on an "as needed" or "as requested" basis;
- (3) Immediately report cases of suspected child abuse / neglect to DHS Child Protective Services Unit, as required by law.

El Dorado County Department of Human Services agrees to the following:

- Refer. as appropriate, domestic violence and sexual assault victims to the Women's Center; (1)
- (2)Request Women's Center staff to accompany victims of domestic violence and sexual assault when appropriate; and
- (3) Engage in cross-trainings with the Women's Center staff on an "as needed" or "as requested" basis.
