Serves as the Chief Executive Officer of the only Federally Qualified Health Center (FQHC) in El Dorado County. Oversees the administration of services to approximately 12,000 patients, with a \$15 million annual budget and staff of 150. Provided services include: medical, behavioral health, psychiatry, dental, podiatry and Medication Assisted Treatment (MAT). Responsible for executive oversight of five clinic locations including oversight of clinic administration; strategic planning and development; financial stability; maintaining compliance with federal requirements, grant management, budget development and compliance, community relationship building and outreach and marketing. Overseeing the development of a \$16 million capital project for a new 30,000 square foot clinic with expanded health care services anticipated for 2021. Provides management oversight and direction to senior management team and reports to the El Dorado County Community Health Center Board of Directors.

California Department of Health Care Services Medi-Cal Eligibility Division Branch Chief, Policy Operations April 2011 – December 2013

Served as the Policy Operations Branch Chief for Medi-Cal Eligibility within the California Department of Health Care Services (DHCS). Responsibilities included supervision and management of eight units within the Policy Operations Branch with approximately 65 employees focused on policy issues related to Medi-Cal eligibility. Responsibilities also included development and oversight of the new Medi-Cal Inmate Eligibility Program

implemented in collaboration with the California Correctional Health Care Services, the Breast and Cervical Treatment Program, Security and Integrity of Medi-Cal data and eligibility policy development. Interfaced with partners on Medi-Cal systems management, Medi-Cal eligibility policy and compliance with federal and state statues, coordination of shared goals with other state departments, counties and stakeholders. Also worked with the Health Benefits Exchange on the development of eligibility policy, processes and planning for outreach and communication to potential enrollees.
