RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION PROGRAMMING EXCHANGED REGIONAL SURFACE TRANSPORTATION PROGRAM FUNDS AND AMERICAN RECOVERY AND REINVESTMENT ACT REGIONAL SURFACE TRANSPORTATION PROGRAM FUNDS REVISING RESOLUTION 09/10.18

WHEREAS, pursuant to California Government Code, Title 7.91, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds; and

WHEREAS, the American Recovery and Reinvestment Act (ARRA) was enacted on February 17, 2009, and provides funding for various transportation projects; and

WHEREAS, in January of 2010 the Federal Highways Administration and Caltrans advised Regional Transportation Planning Agencies to anticipate a second round of economic stimulus funding from the Jobs for Main Street Act; and

WHEREAS, at the February 4, 2010 EDCTC approved the programming of Exchange Regional Surface Transportation Program (RSTP) funding to assist with preliminary engineering and support costs for Jobs for Main Street Act projects; and

WHEREAS, on March 2010 the President signed the HIRE Act into law which extended the Federal SAFETEA-LU transportation bill to the end of the year and eliminated the potential for additional stimulus funds for transportation; and,

WHEREAS, the El Dorado County Department of Transportation has commenced work on road rehabilitation projects on North Shingle Road, Latrobe Road, and Newtown Road, and the City of Placerville has commenced work on a project on Morrene Drive; and

WHEREAS, maintaining the programming of Exchange RSTP funding for North Shingle Road (\$40,000), Latrobe Road (\$120,000), Newtown Road (\$120,000), and Morrene Drive (\$30,000) will support completion of those high priority projects; and.

WHEREAS, EDCTC has worked with Caltrans to identify \$26,368 in remaining ARRA funds; and,

WHEREAS, the City of Placerville can utilize remaining ARRA funds on the Morrene Drive road rehabilitation project; and

NOW THEREFORE, BE IT RESOLVED, that the El Dorado County Transportation Commission does hereby program Exchanged RSTP funds in the amount of \$310,000 and ARRA RSTP funds in the amount of \$26,368 as follows;

- 1. \$40,000 in Exchange RSTP for a road rehabilitation project on North Shingle Road
- 2. \$120,000 in Exchange RSTP for a road rehabilitation project on Latrobe Road
- 3. \$120,000 in Exchange RSTP for a road rehabilitation project on Newtown Road
- 4. \$30,000 in Exchange RSTP for a road rehabilitation project on Morrene Drive
- 5. \$26,368 in ARRA RSTP for a road rehabilitation project on Morrene Drive.

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION PROGRAMMING JOBS FOR MAIN STREET ACT 2010 AND **EXCHANGED REGIONAL SURFACE TRANSPORTATION PROGRAM FUNDS**

WHEREAS, pursuant to California Government Code, Title 7.91, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds; and

WHEREAS, the Jobs for Main Street Act of 2010 is anticipated to be enacted in February, 2010, and will provide funding for various transportation projects; and

WHEREAS, The City of Placerville has identified the following projects to be funded through the Jobs for Main Street Act, for a total amount of \$1,800,000:

- 1. Overlay of Hocking/Morrene Drive; Hocking Street-Mosquito Road to Morrene Drive, and Morrene Drive, Hocking Street to Giovanni Drive.
- 2. Overlay of Placerville Drive/Ray Lawyer Drive; Placerville Drive-Fair Lane to 1,200 feet east of Cold Springs Road, and Ray Lawyer Drive-Placerville Drive to US 50 Overcrossing.
- 3. Overlay of Canal Street/Spring Street/Lower Main Street; Canal Street-Middletown to Bee Street, Spring Street-Coloma Street to Bedford Avenue/US 50, Lower Main Street-Sacramento Street to Canal Street; and

WHEREAS, El Dorado County has identified the following projects to be funded through the Jobs for Main Street Act, for a total amount of \$3,000,000:

- 1. Overlay of North Shingle Road from Ponderosa Road at US 50 to Green Valley Road
- 2. Overlay of Newtown Road from Mining Brook Road to Pleasant Valley Road
- 3. Overlay of Forni Road from Missouri Flat Road to Placerville City limit
- 4. Overlay of Greenwood Road from Marshall Road to SR 193; and

WHEREAS, The City of Placerville has identified the following projects as back-up projects, for a total amount of \$450,000, to be funded through the Jobs for Main Street Act, in the event that excess funding is available after completion of the priority projects:

- 1. Overlay of Mosquito Road-Broadway to Placerville City Limit
- 2. Overlay of Bedford Avenue-US 50 to Placerville City Limit; and

WHEREAS, El Dorado County has identified the following back-up project, for a total amount of \$370,000, to be funded through the Jobs for Main Street Act, in the event that excess funding is available after completion of the priority projects:

Overlay of Greenstone Road from Green Valley Road to Mother Lode Drive; and

WHEREAS, The City of Placerville and El Dorado County have requested Exchanged Regional Surface Transportation Program (RSTP) funding to assist with preliminary engineering and support costs associated with the rapid delivery of the Jobs for Main Street Act of 2010 projects, as follows;

- \$630,000 in Exchanged RSTP Funds for El Dorado County Department of Transportation support costs, and \$150,000 for back up project support costs
- \$180,000 in Exchanged RSTP Funds for City of Placerville Public Works Department support costs and \$45,000 for back up project support costs; and

WHEREAS, the proposed projects are consistent with the City of Placerville and El Dorado County Pavement Management Programs, the Regional Surface Transportation Program guidelines, and the Jobs for Main Street Act of 2010 guidelines; and

NOW THEREFORE, BE IT RESOLVED, that the El Dorado County Transportation Commission does hereby program Jobs for Main Street Act of 2010 and Exchanged RSTP funds as follows;

- \$3,000,000 in Jobs For Main Street Act 2010 Funds for El Dorado County Road Rehabilitation Projects, and \$370,000 for a back up road rehabilitation project
- 2. \$1,800,000 in Jobs for Main Street Act 2010 Funds for City of Placerville Road Rehabilitation Projects, and \$450,000 for back up road rehabilitation projects
- 3. \$630,000 in Exchanged RSTP Funds for El Dorado County Department of Transportation support costs, and \$150,000 for back up project support costs
- 4. \$180,000 in Exchanged RSTP Funds for City of Placerville Public Works Department support costs, and \$45,000 for back up project support costs
