I write in support for the consideration of Resolution No. 069-2021 within the Board of Supervisors of El Dorado County, which calls for the removal of mask mandate rules imposed on our children within our local schools.

I believe a free society allows its citizens to make their own decisions over what risks they are willing to run and what precautions they are willing to take according to their own circumstances to protect their health. In an epidemic, individuals' assessments of risk might convince them to avoid crowded theaters or restaurants, wash their hands more frequently, avoid handshakes, or wear masks. These acts don't require force and don't make demands on others. They are a matter of individual judgment and choice.

Resolution No. 069-2021 emboldens this principle, to allow the citizens of a free society to have the option to determine what is best for their children's health. I support the efforts of the El Dorado County Board of Supervisors to ensure the children in our communities' schools are allowed the choice to make their own best judgements.
