# IV. Item # 26-21-0540 Directions from the Board of Supervisors May 18, 2021 meeting including a recommendation from the Agricultural Commission to Explore Hemp.

On May 18, 2021 The Board of Supervisors heard Item # 26. 21-0540 from the Hemp Ad Hoc Committee recommending the Board conceptually approve an Ordinance for a permanent ban on hemp cultivation in El Dorado County. A motion was made by Supervisor Thomas, seconded by Supervisor Novasel to: 1) Direct the Sheriff and the Agricultural Commissioner/Sealer of Weights & Measures to explore Hemp with the Agricultural Commission and return to the Board in November 2021 with a recommendation or update; and 2) Direct the Planning and Building Department Director to explore economic opportunities relative to Hemp with the Community and Economic Development Advisory Committee and return to the Board in November 2021 with a recommendation or update.

V. A review requested by Somerset Gourmet Farm to explore a proposed 2021 Industrial Hemp Agricultural Research Project relating to the study on the influence of Industrial Hemp in wine grapes.

### SUBJECT: Letter of recommendation to support a research project such as the one proposed involving the University of California, Davis and a local El Dorado County vineyard

During the Agricultural Commission's regularly scheduled ZOOM meeting held on June 9, 2021, 6:30 pm the Commission heard a request from The Somerset Gourmet Farm located at 6540 Perry Creek Road, Somerset, California to conduct a preliminary research study on the influence of Industrial Hemp in wine grapes. In collaboration with Dr. Anita Oberholster, UC Davis Extension, Viticulture Department, the proposal is to interplant 500 Industrial Hemp plants in the Fairplay Appellation Zinfandel Vineyard. At various intervals, grape, air quality and meteorological samples will be measured, recorded and collected for laboratory analysis. The wine grapes harvested will be professionally made into wine. The grape analysis at harvest will be examined for any influences from the hemp planting. The wine made from those grapes

will be additionally analyzed. The project will have a control field sufficient distance from the interplanted Industrial Hemp field to allow a scientific comparative analysis.

County Counsel Daniel Vandekoolwyk and Commissioner Charlene Carveth addressed the Commission and mentioned that in order to accommodate this recommendation the Board of Supervisors would require an ordinance change on the existing EDC ordinance for a moratorium on Hemp # 5138. In addition, Ms. Carveth informed Commission that due to the policy and legal requirements required to amend an ordinance, it was not possible for those revisions to be implemented in time to allow for this project to be conducted during the 2021 Hemp growing season.

Due to the importance of having a local study measuring the impact of hemp on local grapes in El Dorado County the Agriculture Commission believes this research that is being proposed is very important for our growers to be a part of and will assist the Agriculture Commission in bringing a meaningful recommendation to your Board in November as requested on May 18, 2021 Legistar item #21-0948.

The Commission believes that without this data they will not be able to provide comprehensive recommendations by November 2021 as requested by the Board of Supervisors. However, if there's not enough time to modify the ordinance for the 2021 growing season on behalf of the Commission I am requesting the Board of Supervisors ensure the necessary revisions are made to the County's ordinance to allow for such a study during the 2022 growing season.

The motion the Commission is making is for a recommendation request only for this study to be conducted with your approval. Here's a copy of the motion that was passed on June 9, 2021

It was moved by Commissioner Draper and seconded by Commissioner Bacchi to recommend sending a letter of request to have the Hemp Moratorium lifted for this study to move forward no later than July 15, 2021, involving the University of California, Davis as the study here locally could have significant impact on our wine grape industry and effects from the Hemp.
