# COMMUNITY PUBLIC HEALTH NURSING DIVISION MANAGER

## **DEFINITION**

Under direction, plans, organizes, administers, coordinates oversees and evaluates staff and directs activities of community and services for public health nursing; administers practice and the work of professional, nursing and other professionally licensed staff performing difficult, complex and technical and other support staff in the provision of duties related to public health services through a variety of clinicclinic and field services; assists with program planning and budgeting; coordinates assigned activities with other County departments and outside agencies; provides expert highly responsible and complex professional assistance to County staff and the public in public health promotion and service delivery activities. The incumbent serves as the Director of Public Nursing as outlined in California Code of Regulation Title 17 Public Health.

## DISTINGUISHING SUPERVISION EXERCISED AND RECEIVED

<u>Receives direction from assigned executive management personnel.</u> Exercises direct supervision over supervisory, professional, technical, and administrative support staff. Supervision and direction may be provided directly or through subordinate supervisors.

# **CLASS CHARACTERISTICS**

This class has division level responsibility for is a management classification responsible for the County's public health nursing services function, including a variety of specialized practice and other affiliated licensed disciplines of physical health education and promotion programs and field services. The incumbent is responsible for <u>.</u> Responsibilities include ascertaining community health needs, recommending programs to meet those needs and, directing their development and implementation. The incumbent is responsible for developing and implementing division and departmental, budget administration and reporting, and program evaluation as well as performing and directing many of the day-to-day activities of the nursing programs. Incumbents serve as a professional-level resource for organizational, managerial, and operational analyses and studies. Performance of the work requires the use of considerable independence, initiative, and discretion within established guidelines.

# EXAMPLES OF TYPICAL JOB FUNCTIONS (Illustrative Only)

- Develops and/or manages and administers public health nursing based on community assessment data and overall <u>Public Health Division service goals</u>, and objectives and.
- Evaluates nursing practice proficiency, California Practice Act compliance, adherence to nursing professional code of conduct and advises the County on best practices and areas of improvement
- Selects, trains, evaluates, and disciplines subordinate staff.
- Serves as a resource for interpreting federal, state and local standards of public health nursing practice

Assists in addition to furthering County goals and objectives.

#### **EXAMPLES OF DUTIES** (Illustrative Only)

- Plans, organizes, coordinates and directs, through subordinate supervisors, the work of the Community Public Health Nursing Division, providing infant, child and adult health programs and community nursing services.
- Develops and directs the implementation of goals, objectives, policies, procedures and work standards for the division; participates in the budget process.

- Develops and implements the development of management systems, procedures and standards for program monitoring and evaluation; recommends procedural modifications. assures proper procedures are in place and followed.
- DiroctsPerforms analysis and prepares detailed written reports of findings pertaining to the quality and efficiency of services provided within public health nursing programs.
- <u>Assists in</u> the preparation of a variety of studies and reports relating to current and long-range service provisions within the County.
- Directs the selection, supervision, training and work evaluation of division staff; supervises contract staff as required.
- <u>Overseesprogram budgets in support of the overall Division budget.</u>
- <u>Coordinates the</u> application for, execution and monitoring of grants within the division; reviews-Division; develops directly or through delegation scope of work, budget and works, budgets, periodic or annual reports for all grant programs.
- Assists subordinates and peers in planning and organizing public health clinics; approves<u>community level</u> outreach, intervention and events; reviews and evaluates schedules, staffing and caseload assignments<u>ratios and case assignment appropriateness</u>.
- Conducts physical assessments; dispenses medicinal products and therapeutic agents; performs diagnostic testing/screenings, immunization techniques, and withdrawal of human blood.
- Reviews and interprets laboratory findings and provides intervention in accordance with standardized procedures and protocol at the facility level and in the community as appropriate.
- Prepares, directs the preparation of and reviews periodic and special reports to for a variety of state or federal agencies for health issues./
- Coordinates the work of the division with that of other divisions, departments, outside agencies and individuals.
- Participates in on-site compliance reviews as conducted by state surveyors; corrects reported deficiencies.
- Monitors developments related to health promotion and public health nursing matterspractice and scope, evaluates theirpotential or real impact on County nursing programs and operations, and recommends policy, standard and/or procedural improvements.
- Represents the Division and public health nursing at community organizations, public gatherings, and meetings.
- Attends and participates in professional group meetings; stays abreast of new trends and innovations as they relate to the areas of assignment.
- Attendance and punctuality that is observant of scheduled hours on a regular basis.
- Performs other duties as assigned.

# QUALIFICATIONS

#### **Other Requirements:**

Must possess a valid driver's license. Must possess a valid license to practice as a registered nurse in the State of California, and a valid California Public Health Nursing Certificate.

- o Identify cultural patterns influencing community health practices.

#### **Education and Experience:**

A combination of the required experience, education, and training that would provide the essential knowledge, skills, and abilities is qualifying; however, education may not solely substitute for the required experience.

Equivalent to graduation a bachelor's degree in nursing from a an accredited four-year college or university accredited by the National League for Nursing with major coursework in nursing and three;

AND

<u>Three</u> years of supervisory or administrative public health nursing experience which included involvement in fiscal management and program planning, development and administration. <u>A Master's degree in public health or public</u>

health nursing is desirable.

**NOTE:** The above qualifications are a typically accepted way of obtaining the required knowledge and skills. A Master's degree in nursing, public health, or advanced nursing practice is desirable.

## **Licenses and Certifications:**

Possession of a California Registered Nurse license issued by the California State Board of Registered Nursing or eligibility for Registered Nurse licensure reciprocity in the State of California.

Possession of a California State Public Health Nursing certificate.

Possession of, or ability to obtain and maintain, a valid California Driver's License by time of appointment and a satisfactory driving record.

#### PHYSICAL DEMANDS

Must possess mobility to work in an office setting; use standard office equipment, including a computer; some positions may be required to operate a motor vehicle; vision to read printed material and a computer screen; and hearing and speech to communicate in person and over the telephone. Standing in and walking between work areas is frequently required. Finger dexterity is needed to access, enter, and retrieve data using a computer keyboard or calculator and to operate standard office equipment. Positions in this classification frequently bend, stoop, kneel, and reach to perform assigned duties, as well as push and pull drawers open and closed to retrieve and file information. Employees must possess the ability to lift, carry, push, and pull materials and objects up to 25 pounds. Reasonable accommodations will be made for individuals on a case-by-case basis.

# ENVIRONMENTAL CONDITIONS

Employees predominantly work in a facility or office environment with moderate noise levels, controlled temperature conditions, and no direct exposure to hazardous physical substances. Employees may interact with upset staff and/or public and private representatives in interpreting and enforcing departmental policies and procedures.

#### WORKING CONDITIONS

Must be willing to work after hours, weekends, and holidays as needed.

As required by Internal Revenue Service Publication 1075, individuals in positions that have access to Federal Tax Information (FTI), will be subject to a background investigation and a criminal history check. In addition, individuals hired into positions that have access to FTI will be re-investigated at least once every ten (10) years.
