Despite the hazardous smoke conditions due to the Caldor Fire, the past two weekends the American River Resort and the Coloma Resort have been filled nearly to capacity. I've been amazed by the number of people risking their heath by rafting and camping under the worse fire in EDC history.

Hidden in the Chapparral:

Mt. Murphy pictured on the first page is where the first religious service in EDC was led by Henry Bigler, one of the Mormon workers at the mill. Patrick Murphy had built a fort atop Mt. Murphy where he placed a cannon so he could signal the mail stage arriving from Sacramento. Mt. Murphy is the iconic historic backdrop to the 1848 gold discovery by James Marshall and the Gold Rush that changed the face of our entire nation.

As I related last week, Mt. Murphy was set ablaze 5 times within 8 years. I lost my beloved golden retriever as a result of one of the 30 fires ignited by 3rd generation arsonist Ben Cunha. The smell of frying bacon and steaks frequently fills my home from those who choose to cook outdoors amidst hazardous fire conditions and put those of us on the north side of the one-lane Mt. Murphy bridge at risk of being trapped. There is no evacuation route or plan for residents whose only means of escape is the one-lane bridge which would likely be blocked by the RVs exiting the Coloma Resort. It is another Paradise Fire disaster just waiting to happen.

Worse yet, past and present supervisors have been unresponsive to citizen's concerns about public safety, code and law enforcement, as well as Public Record Act requests for information. Tiffany Schmid and Rafael Martinez have been particularly unresponsive to PRAs involving roads and code enforcement. This is no time to be evasive. Now is the time for the BOS to take action and ensure that it is put on the agenda pursuant to section 54954.2(a) of the Brown Act. Lori, since this involves your district, it is up to you to respond to your constituents and get this on the agenda.

FOR THE RECORD, LORI PARLIN REFUSED TO RESPOND AS REQUIRED BY LAW.






Note dry vegetation/debris:





This valley is in the **PURPLE AND MAROON**/VERY UNHEALTHY-HAZARDOUS Air Quality Status, which means NO FLAME DAYS, NO SPARK DAYS. It is predicted that this will continue until the nearby Caldor fire is contained. Thus, it would be prudent to avoid all open fires and spark risk activity in the valley until further notice. As of this morning the Caldor Fire is 9% contained, so our firefighters are making palpable progress. However, slow it feels to us.

The direction from the Caldor Fire (not Coloma/Lotus) determines when we are in its path.
