Summary of qualifications

I have been with EI Dorado County Probation for 8 years. Six of those years were spend at the Juvenile Treatment Center working with youth directly. I have seen the Child Abuse first hand and as a mandated reporter I have made numerous reports. I have also been there for the youth at there worse time in life and assisted them in getting the treatment needed. I see that there is a lack of support and representation in South Lake Tahoe and as the only facility for youth is in South Lake Tahoe, I feel there needs to be representation. I have two boys, 20 and 18 years old and I see it with there friends as well the lack of support. I have the life experience needed to be on this Council and represent El Dorado County from a Probation standpoint but also a human stand point.

Affiliations with professional and/or community groups

I have been involved with the South Lake Tahoe School District as the Juvenile Intake Officer and the Officer in charge of supervision. I have a close working relationship with the school staff as well as the school Resource Officers with SLT Police Department. I volunteer and run for the Rock Tahoe Half Marathon which donates proceeds to community organizations and assist in youth programs. I have been an active Probation Officer volunteering with the Juvenile Service Council which helps with youth activities and outreach. I have ran in and volunteered for 3 Strands, that benefits stopping sex trafficking. On weekends I work at Barton Hospital as a Security Officer and I see children right after an Abuse event. The youth need to be better represented right after an event as there is trauma involved that will effect then for the rest of there lives.

Why do you seek appointment?

As a father and active Probation Officer, I have seen threw the looking glass when it involves child abuse. The Probation Department has not had representation on the Child Abuse Prevention Council and I feel we need a voice at the table. We have first hand knowledge of Child Abuse events and I see where we are underserved. Working closely with Child Protective Services I know there needs to be more services for placement of the youth instead of the Juvenile Treatment Center. We need better outreach, housing, placement, counseling, treatment. Living in South Lake Tahoe, I feel we are underserved. I want to be that voice not just for El Dorado County but for South Lake Tahoe youth.

My life before Probation, I am an educated Information Systems Specialist. My career spanned 20 years working in Information Technology at HSBC bank, Exxon Mobile and Microsoft. At Microsoft I was the Global Director of User Acceptance Testing in charge of a fluctuating group of 30 to 50 testers world wide. I am well versed in managing very large projects, multi tasking and coordinating communication between multiple platforms and teams.
