Dear Chair Hidahl and Board of Supervisors -

I am a Board appointee myself, and I strongly support giving each nominating Supervisor broad discretion in their choices. However broad, discretion should not be unlimited, and I oppose Supervisor Turnboo's nomination of Sue Taylor to replace Cheryl Bly-Chester on the County Planning Commission.

Given the circumstances of Ms. Bly-Chester's removal, her replacement should be someone known for collegiality, consensus-building, and 100% respect for County decisionmakers, staff, the public, and those with differing views. Sue Taylor's long history of public acrimony, sanctimony, conflict, and litigation in this County clearly shows that she is not that person. Before anyone gets their panties in a twist over what I'm going to say about my objection to the appointment of Sue Taylor to the Planning Commission, they first need to read the FACTS and examine the EVIDENCE contained in the letter attached to this agenda item.

With that being said, Sue Taylor has demonstrated that she does not possess the integrity and honesty to serve as a commissioner in an unbiased manner. A few years ago it was necessary to kick Sue Taylor and Lori Parlin out of my home when it was discovered that Lori Parlin had <u>fraudulently</u> swapped Sue Taylor's name for hers on legal notifications addressed to the BOS involving land use. Then claiming to hold the BOS accountable to their oaths of office, Lori posted the fraudulent letters to the Save Our County website. Despite several demands I made to Lori and Sue to remove the fraudulent postings, the letters still remain posted on the SOC website. As administrator of the Sue Taylor's website, Lori has a conflict of interest. That means she would be required to recuse herself from any BOS decisions involving SOC

Astute citizens need to watch the entirety of the April 22<sup>nd</sup> PC meeting that was the subject of such controversy. The conduct of the entire meeting was beyond absurd. The worst part was that it was done under the direction of county counsel. Dr. Bly-Chester actually had the chuzpah to call out the Commissioners on their violations of the Brown Act which was her rightful duty and in accordance with her oaths of office. In retaliation for doing the right thing, Dr. Cheryl Bly-Chester was removed by the votes of three liberal Supervisors on August 31st. Although Cheryl filed her appeal, she was denied due process of law and the Notice of Vacancy was posted September 10th.

The October 14<sup>th</sup> PC meeting also continued outside of the law after Breann Mobius confirmed *on the record* that they failed to have a quorum, rendering their subsequent actions null and void. Then there is also the issue of Kim Dawson falsifying the minutes and her failure to lawfully respond to a PRA relevant to that meeting.

My area of expertise is the Brown Act and Conflicts of Interest. I'd like to take this occasion to remind you of the opening statement of the preamble to the Brown Act, "The people, in delegating authority, do <u>not</u> give their public servants the right to decide what is good for the people to know and what is not good for them to know."

Citizens should be *demanding* to know why Cheryl was denied her right to a hearing and due process, and why a Notice of Vacancy was never posted for James Williams <u>as required by law</u>. The answer is Lori Parlin had already selected Andy Nevis as his replacement, which meant no other candidates had the opportunity to apply. After the BOS refused to pull the item for public discussion as I requested, the item was passed on Consent, and in so doing they violated the Brown Act and the Rights of the Public. There never has been any transparency, no meaningful public dialog, and certainly no accountability--simply the maintenance of the corrupt status quo.

Ladies and gentlemen, that is not "good governance"; it is the hallmark of a totalitarian regime characterized by Bureaucratic Shenanigans primarily due to bad legal advice emanating from County Counsel and the CAO. These meetings have progressively gone from bad, to worse, to blatantly outrageous violations of the Brown Act and the rights of the people. This item should never have even appeared on today's BOS agenda. The only logical solution is the reinstatement of Dr. Bly-Chester to the Planning Commission, and a serious investigation into EDC corruption that is undermining the essential liberties of El Dorado county citizens.

### CALIFORNIA BROWN ACT

#### **PREAMBLE**:

"The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people do not yield their sovereignty to the bodies that serve them. The people insist on remaining informed to retain control over the legislative bodies they have created."

### CHAPTER V.

### RIGHTS OF THE PUBLIC

\$54954.3 Public's right to testify at meetings. (c) The legislative body of a local agency shall not prohibit public criticism of the policies, procedures, programs, or services of the agency, or of the acts or omissions of the legislative body. Nothing in this subdivision shall confer any privilege or protection for expression beyond that otherwise provided by law. Care must be given to avoid violating the speech rights of speakers by suppressing opinions relevant to the business of the body. As such, members of the public have broad constitutional rights to comment on any subject relating to the business of the governmental body.

Any attempt to restrict the content of such speech must be narrowly tailored to effectuate a compelling state interest. Specifically, the courts found that policies that prohibited members of the public from criticizing school district employees were unconstitutional. (Leventhal v. Vista Unified School Dist. (1997) 973 F. Supp. 951; Baca v. Moreno Valley Unified School Dist. (1996) 936 F. Supp. 719.) These decisions found that prohibiting critical comments was a form of viewpoint discrimination and that such a prohibition promoted discussion artificially geared toward praising (and maintaining) the status quo, thereby foreclosing meaningful public dialog.

54954.2 E (3) No action or discussion shall be undertaken on any item not appearing on the posted agenda, except that members of a legislative body or its staff may briefly respond to statements made or questions posed by persons exercising their public testimony rights under Section 54954.3.

Where a member of the public raises an issue which has not yet come before the legislative body, the item may be briefly discussed but no action may be taken at that meeting. The purpose of the discussion is to permit a member of the public to raise an issue or problem with the legislative body or to permit the legislative body to provide information to the public, provide direction to its staff, or schedule the matter for a future meeting. (§ 54954.2(a).)
