I am pleased that previous City Map 1 for the November 3rd redistricting workshop has been adjusted to include Cameron Park in one District. On behalf of myself and my Cameron Park neighbors, thank you very, very much.

Should the Supervisors choose any of the three City Map alternatives, please consider including in District 2 the approximately 170 homes north of Green Valley Road in neighboring Rescue (estimated 500 population).

City Alt 2 includes homes east of Starbuck Road. But additional homes west of Starbuck, further west to the Peridot/Aquamarine neighborhood and on to the small Travois neighborhood also share suburban commonality to Cameron Park...and are included in the Cameron Park census designated place area.

Should you grant this change, the resulting 500 population addition to District 2 and 500 reduction to District 4 appears to be capable of being offset by shifting 500 population from the area in between Frenchtown and El Dorado to District 4.

Supervisors,

I offer these comments today, in an effort to support the herculean task that your Board is charged with completing, with the support of County staff to establish the new supervisorial district boundaries based on the final counting of the 2020 Census.

As a 26-year resident of El Dorado Hills in the Bass Lake area, we realize that our El Dorado Hills community, our Bass Lake community, and our adjacent community of Cameron Park, all fall under similar suburban conditions and challenges. As such, when this redistricting effort was launched, my primary concern was that our suburban communities, as the largest population centers in the County, could move forward for the next decade with representation that acknowledges our suburban needs, and is respectful of the challenges and concerns of our community.

Clearly, by population size, the entirety of El Dorado Hills cannot remain in a single district. Over the past ten years, I've felt that segments of our El Dorado Hills communities that were outside of District 1 representationally have had a minority voice in District 2 and District 4. I also believed that Cameron Park, the third largest population center in El Dorado County, also suffered by being spread across two mostly rural districts, where their suburban concerns were easily lost due to their being a small segment of their respective districts.

Our only two incorporated cities, South Lake Tahoe, which is only a few thousand residents by population larger than Cameron Park, and tens of thousands of residents smaller than El Dorado Hills, and Placerville, which is several thousand residents by population less than Cameron Park, and almost four times smaller than El Dorado Hills, have effective local representation via their city councils. This is why I feel that respectful County representation at the Board of Supervisors is critical for our largest unincorporated suburban communities.

Several of the initial Draft Alternative maps in October seemed to perpetuate the issue of our largest communities being segmented into small pieces of rural districts – effectively minimizing those needs and concerns of our large suburban communities. Placing a few hundred residents from El Dorado Hills into a district of 38,237 total residents is not respecting communities of interest. Even having 4,000 residents of El Dorado Hills in a district of 38,327 residents would marginalize their voice, proportionally.

Of those early maps, I was alarmed that our Bass Lake Community of under a thousand homes was suggested to be placed into rural districts – that is not representative of our community.

Of the three maps before you in Legistar today, each one not only proposes to place the Bass Lake Community into rural districts, but more egregiously, splits our small community into two districts – using the fence line between backyards in Bridlewood Canyon and the Woodridge/The Hills of El Dorado villages as a Supervisorial District Boundary. In the PDF maps in Legistar, the text on the maps makes it difficult to read the boundary lines, as in this example from the Draft City Alternative Revised 1:



This satellite image with the added red line representing the fence line between neighbors that is being proposed as a supervisorial district boundary:



The Bass Lake area is a community – using a fence as a district boundary line is absurd. The result is marginalizing our community's representation and our interests.



I was happy to work with a focus group of El Dorado Hills residents, working on recommending a more representative alignment of district boundaries, with volunteer members representing:

- The Age Restricted Communities south of US50 Heritage, and Four Seasons
- The Bass Lake area
- Highland Hills
- Serrano El Dorado residents
- The Serrano Owners Association
- The El Dorado Hills Chamber of Commerce

These El Dorado Hills stakeholders recognized that the more natural boundaries in El Dorado Hills centered on US50. Using US50, north and south of the highway, respected existing neighborhoods and villages, in the largest population center in our County, keeping them intact representationally as large blocks in each district, as is appropriate. We also sought to keep respectful suburban representation, as best as we could possibly provide, for our suburban neighbors in Cameron Park.



The resultant map, as thoughtfully constructed due to the efforts County Staff, is not our ideal solution, but we believe is the fairest representation of our communities. To be blunt, the political considerations of drawing boundaries was our largest obstacle, even though political considerations are instructively not to be a component of debate in this effort.

As Vice President of the non-profit Bass Lake Action Committee, which since 2003 has utilized the tagline "The Voice of The Bass Lake Community" in our widely read monthly *Bass Lake Bulletin*, I have heard from members and residents that are alarmed by the concepts of splitting our community's representation. As the Chair of the El Dorado Hills Area Planning Advisory Committee, and a member of the El Dorado Hills Community Council, I have had discussions with numerous members of our community that have the same concerns regarding placing small segments of our residents into multiple districts where their voices may be marginalized. I feel that the El Dorado Hills Community Draft Redistricting Alternative represents the best compromise at this late date to respect the representational needs of our El Dorado Hills and Cameron Park Communities. I urge you to consider adopting as many elements of this proposed draft map as possible.

Members, Board of Supervisors El Dorado County, California

Residents of the Heritage, Blackstone, and Four Seasons villages have joined together into a "community of interest" (COI) pursuant to the California Redistrict Commission guidelines: "the California Constitution defines a community of interest as a population which shares common social and economic interests that should be included within a single district for purposes of its effective and fair representation."

We seek to have our COI served within a single El Dorado County Supervisorial district. We believe that the population of El Dorado Hills is best served by two members of the Board of Supervisors. In order to achieve this goal, contiguous adjustment to current district representation is required. A logical and easily understandable boundary is Highway 50, with the population to the north belonging in District 1 and to the south belonging in District 2.
