- **I.** Section 3 is amended to read as follows:
 - 3. Complete the Subdivision improvements contemplated under this Agreement on or before November 14, 2022.

- II. Section 27 is hereby amended to read as follows:
 - 27. All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid, and return receipt requested.

Except as herein amended, all other parts and sections of that certain Agreement dated November 14, 2017, shall remain unchanged and in full force and effect.
