

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Authorize the Director of Transportation to Temporarily Close a Section of Durock Road between Shingle Lime Mine Road and Business Drive During a Portion of the 2010 and 2011 Construction Seasons

WHEREAS, the County plans to replace, realign and widen a portion of Durock Road and install a traffic signal at the intersection of Durock Road and Business Drive for Capital Improvement Project No. 73354 during the 2010 and 2011 construction seasons; and

WHEREAS, existing pavement and culverts will be removed and replaced as part of the Project; and

WHEREAS, in order to replace the existing pavement and culverts, widen the road and signalize the intersection, Durock Road between Shingle Lime Mine Road and Business Drive will need to be closed for approximately six (6) months; and

WHEREAS, an alternate access route/detour will be available during the temporary closure and traffic will be directed by signage to this route/detour; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing;

WHEREAS, pursuant to California Streets and Highways Code Section 942.5, the Board of Supervisors is authorized to close a county highway during construction, improvement or maintenance operations thereon, and pursuant to California Streets and Highways Code Section 942.6, the Board of Supervisors is further authorized to delegate such authority to the Road Commissioner, i.e., the Director of Transportation; and

NOW, THEREFORE, BE IT RESOLVED that the Director of Transportation is authorized to order the temporary closure of Durock Road, between Shingle Lime Mine Road and Business Drive, and to establish an alternate access route/detour for traffic use during the time of the temporary closure. The anticipated temporary road closure will last approximately six (6) months, during early September 2010 through June 2011, for the planned replacement, realignment, widening, signalization and related construction activities. The precise dates of the temporary road closure are to be determined by the Director of Transportation, with notification of the pending temporary road closure and detour to be provided to the County Supervisor of District 2, business owners, residents, the general public, the El Dorado County Transit Authority and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.
