Resolution to Authorize the Director of Transportation to Temporarily Close Mosquito Road and Bridge (South Fork of the American River) During a Portion of the 2010 Construction Season

WHEREAS, the County plans to rehabilitate the Mosquito Road Bridge by replacing older timber structural elements and the road surface for Capital Improvement Project No. 77120 during the 2010 construction season; and

WHEREAS, the Bridge asphalt concrete approaches and the roadway timbers will be removed and replaced as part of the rehabilitation Project; and

WHEREAS, in order to perform the rehabilitation work, the Mosquito Road and Bridge will need to be closed for no more than ten (10) weeks; and

WHEREAS, an alternate access route/detour will be available during the temporary closure and traffic will be directed by signage to this route/detour; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

WHEREAS, pursuant to California Vehicle Code Section 21101(e) and California Streets and Highways Code Section 942.6, the Board of Supervisors may designate the Director of **T**ransportation to determine the exact dates and times for the closures;

NOW, THEREFORE, BE IT RESOLVED that the Director of Transportation is authorized to order the temporary closure of Mosquito Road and Bridge, and to establish an alternate access route/detour for traffic use during the time of the temporary closure. The anticipated temporary closure period will be approximately ten (10) weeks, and will occur during late July to early October 2010, for the planned asphalt concrete and timber replacement and related construction and bridge rehabilitation activities. The precise dates of the temporary road and bridge closure are to be determined by the Director of Transportation, with notification of the pending temporary closure and detour to be provided to the County Supervisors of Districts 3 and 4, business owners, residents, the general public, the El Dorado County Transit Authority, and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Authorize the Director of Transportation to Temporarily Close a Section of Durock Road between Shingle Lime Mine Road and Business Drive During a Portion of the 2010 and 2011 Construction Seasons

WHEREAS, the County plans to replace, realign and widen a portion of Durock Road and install a traffic signal at the intersection of Durock Road and Business Drive for Capital Improvement Project No. 73354 during the 2010 and 2011 construction seasons; and

WHEREAS, existing pavement and culverts will be removed and replaced as part of the Project; and

WHEREAS, in order to replace the existing pavement and culverts, widen the road and signalize the intersection, Durock Road between Shingle Lime Mine Road and Business Drive will need to be closed for approximately six (6) months; and

WHEREAS, an alternate access route/detour will be available during the temporary closure and traffic will be directed by signage to this route/detour; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

WHEREAS, pursuant to California Vehicle Code Section 21101(e) and California Streets and Highways Code Section 942.6, the Board of Supervisors may designate the Director of Transportation to determine the exact dates and times for the closures;

NOW, THEREFORE, BE IT RESOLVED that the Director of Transportation is authorized to order the temporary closure of Durock Road, between Shingle Lime Mine Road and Business Drive, and to establish an alternate access route/detour for traffic use during the time of the temporary closure. The anticipated temporary road closure will last approximately six (6) months, during early September 2010 through June 2011, for the planned replacement, realignment, widening, signalization and related construction activities. The precise dates of the temporary road closure are to be determined by the Director of Transportation, with notification of the pending temporary road closure and detour to be provided to the County Supervisor of District 2, business owners, residents, the general public, the El Dorado County Transit Authority and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.
