## 4. <u>15-1367</u> Appoint MHSA 16/17 Fiscal Year Plan Committee

Commissioner Abram stated that he is looking for members to participate on the MHSA 16/17 Fiscal Year Plan Committee. He would like the Commission to provide input and review of the new format and content of the Draft Plan before it is posted for 30-day public comment. Commissioners Abram, Melnicoe, Clavere, Burke, Boals and applicant Deborah Carter volunteered to participate on the committee.

# 5. <u>15-1368</u> Discussion of Family Involvement in Conservatees Mental Health Treatment Programs and Placements

Commissioner Melnicoe reported that there is ongoing discussion coming from NAMI families regarding conservatorship. She stated that there is no protocol in place and there is little room for family input. Clients will eventually be back with families for natural supports and asked how the conservatorship process can be improved to work better with families.

Alexis Zoss stated that there is a policy and procedure currently being developed. The goal is to ensure families are involved and emphasized a need for education and support to family members. She provided a handout titled "What is Conservatorship?".

Commissioner Lynn asked for an update or report on this topic at the next Mental Health Commission meeting. Commissioner Abram stated that he will check in with Alexis and Director Ashton to see if there is anything new to share at the January meeting.

# 6. <u>15-1369</u> Review / Discussion of 2015 Mental Health Commission Data Notebook

Commissioners Melnicoe and Pond participated with Mental Health staff to complete the 2015 Data Notebook. Commissioner Melnicoe stated that the dual diagnosis statistics were interesting and that this provides a "report card" on where we are at and where the focus needs to be. Commissioner Abram added that there is an ongoing need for housing, as well as an in county Mental Health Rehabilitation Center (MHRC). Assistant Director Charles-Heathers stated that paperwork has been completed for a Request for Information (RFI) to see if any local providers are interested, specifically for assistance to clients with co-occurring disorders.

7. <u>15-1370</u> Update / Discussion on 12am to 8am Crisis Response to hospitals and communication between the Psychiatric Health Facility (PHF) and hospitals

Jamie Samboceti reported that there is a teleconference scheduled for December 7, 2015 with Heritage Oaks (the only repondent to the Crisis Response RFP). She also stated that communication between the PHF and the hospitals has improved greatly and the both the medical doctor and the psychiatrist are reviewing the client charts. Mental Health clinician, Angelina Larrigan, is also meeting with clients and families for discharge planning purposes.

8. <u>15-1371</u> Update on Assisted Outpatient Treatment

Commissioner Abram reported that the RFP for AOT was posted on November 13,

2015 and responses are due by December 30, 2015.

Commissioner Melnicoe asked for more information on the Law Enforcement -Education MOU. Assistant Director Charles-Heathers stated that this MOU is for the schools. She also provided information that she learned at the conference and stated that it is helpful to hear what other counties are doing.

Jamie Samboceti stated that the crisis numbers are improving on both slopes and that the numbers of open clients having a crisis episode has decreased significantly. She recognized the clinical staff on both slopes for doing such a great job maintaining client stability and keeping them from going into crisis as often.

Commissioner Melnicoe asked for an update on CIT. Capt. Jackie Noren stated that there are monthly meetings on the first Thursday of each month at 9:00 am and that things are going well.

Commissioner Clavere asked for an update on the administration of psychotropic medications in the jails. Capt. Jackie Noren reported that they are still in the process of developing policies and procedures for implementation.

Commissioner Boals thanked Mental Health and NAMI for putting on such a nice client Thanksgiving dinner.

Commissioner Burke stated that Supervisor Novasel was unable to attend the meeting tonight due to illness.

Commissioner Clavere stated that he received the data from Lori Walker regarding the indirect and A-87 costs. He will review and submit his questions and findings at the meeting in January.

Commissioner Abram thanked the Commissioners and the Mental Health staff for all their hard work this past year.
