- 8) Approve the Introduction (First Reading) of Ordinance XXX adding a new section establishing regulations for Frontage Improvements on County Roadways, Chapter 12.09 (Attachment 22H);
- 9) Approve the Introduction (First Reading) of Ordinance XXX adding a new section that provides for a General Plan Traffic Impact Mitigation Fee Program, California Code Section 66000 (Attachment 22I);
- 10) Waive full reading, read by title only and continue the adoption of said Ordinances to December 13, 2016 or January 3, 2017 for Final Passage (Second Reading);
- 11) Receive and File the Draft Traffic Impact Mitigation Fee Administrative Manual and Resolution (Attachment 22J), and provide comments towards finalizing the documents;
- 12) Receive and file the Final Outreach Summary Report (Attachment 22K); and
- 13) Receive and File the responses to public comments.
