- A. Amaro RE: Keep program as stand alone and leave staffing at current level. Do not put under Human Services
- F. Vilt RE: Letter from son who is on active duty. This program is essential.
- M. Bowen RE: Son is on active duty. Should reconsider furlough days for this department. They help with much needed crisis services to wives and parents of active military.
- Lt. Colonel J. Derreck RE: Board of Supervisors web page honors Veterans, p 435 of budget book suggests combining functions with Human Services. This would not be good.
- B. Cathcart RE: Services in El Dorado County Veteran's office are excellent and most efficient Veteran's offices in Northern California. They go beyond the normal.

- P. Palant, Conflict Attorney South Lake Tahoe RE: Statistics presented are too low. Each lawyer in SLT had more than 100 cases each. Would like to present the true statistical and case load numbers.
- E. Davenport, Conflict Attorney RE: Numbers presented are low. Can work with staff to clarify the number of cases. Current method of payment encourages the expedition of each file.
