Health and Human Services Agency, Public Health Division, recommending the Board authorize the Chair to sign retroactive Agreement for Services 222-S1311 with Sierra Foothills AIDS Foundation, Inc., for the provision of medical case management and supportive care services for persons living with Human Immunodeficiency Virus or Acquired Immunodeficiency Syndrome. This Agreement is for the term of July 1, 2012 through June 30, 2015 with a not-to-exceed amount of \$450,074.
