Staff will meet to update Pollock Pines community members on what is happening at Forebay Community Park.

The Parks Division will have a booth at the Placer County Fair featuring the Rubicon Trail.

The skate park is doing well and we are hopeful that the Commission can tour the park in the fall. Would like to develop a skate team that can provide demonstrations at events such as the County Fair.

The Old Depot Road property is in escrow and once completed, public meetings will be set up to see what type of bike park users would like to see developed on this property.

Construction for a Class I bike path has begun on the section of the El Dorado Trail, Los Trampos to Halcon and construction for a Class I bike path will begin in the fall of 2019 on the section from Missouri Flat Rd to the town of El Dorado.
