CHIEF ADMINISTRATIVE OFFICE - ECONOMIC DEVELOPMENT UPDATE

Tiffany Schmid, Principal Management Analyst from the Chief Administrative Office, Economic Development Dept., provided a brief update on the following items:

- 1) The County (Economic Development Dept., Human Resources, Health & Human Services Dept., and Community Development Services) attended the Tri-County Job Fair on August 23, 2018, at Rancho Cordova City Hall;
- 2) Tiffany Schmid attended the AEP CA Housing Crisis Seminar on August 3, 2018;
- 3) The County held a second internal meeting on El Dorado County housing issues. A broader stakeholder meeting is being planned, including CEDAC, for October;
- 4) Tiffany Schmid & Chief Administrative Officer, Don Ashton met with the new Director of Economic Development for Rural County Representatives of California (RCRC), Barbara Hayes. RCRC has a new economic development focus and will be providing counties with annual demographic profiles. They are also working on forest resiliency and broadband;
- 5) Greater Sacramento Economic Council (GSEC) is taking on a National attraction strategy;
- 6) The Deputy Director of Planning and Director of Planning and Building recruitments are concluding in the next two weeks;
- 7) Emily Abernathy, Director of Operations at Tahoe Chamber, stated that they will offer the Tahoe Chamber Member discount to people holding memberships at other County Chambers of Commerce for the Level-Up Workshops; and,
