Chief Administrative Office, Parks Division recommending the Commission recommend the Board of Supervisors approve the Park Impact Fee Nexus study completed by SCI Consulting Group, a sub-contractor of Foothill Associates. The purpose of the study was to determine the legal policy basis for the imposition of establishing a community park impact fee and a regional park and trail impact fee.
