CHIEF ADMINISTRATIVE OFFICE - ECONOMIC DEVELOPMENT UPDATES

Kyle Zimbelman, Business and Economic Relations Manager, gave a brief update on behalf of Economic Development that included:

- 1) Representatives from the County attended the 2nd Annual Greater Sacramento Economic Council's dinner on December 6th. As the 2018 winner of the 'Paving the Way' award, the County's Chief Administrative Officer, Don Ashton awarded the 2019 award to the City of Folsom;
- 2) Economic Development staff attended an Ag Tour with Assemblyman Kevin Kiley on December 7th, hosted by Anne Wofford from Wofford Acres;
- 3) The County was featured and also ran an ad in the December Comstock's Magazine and the Comstock's Special Supplement, The California Option;
- 4) Chief Administrative Officer, Don Ashton, along with Economic Development staff will be attending the El Dorado County Tourism Summit on Friday, January 11, 2019. The event will be held in El Dorado Hills at the Holiday Inn Express;
- 5) K & K Veterinary Hospital received approval at the Zoning Administrator Hearing on December 19, 2018;
- 6) The County is hosting a Housing Discussion Panel on Friday, January 25th; and.
- 7) Greater Sacramento Economic Council will be hosting the Certified Champions Program in El Dorado County on February 22, 2019. The event will be held in El Dorado Hills at the Holiday Inn Express. This is the first Champions Program being held on the road.

CEDAC MEMBER UPDATES

Member Long updated the Committee that this may be her last meeting. She will fill in until Supervisor Parlin appoints a new District IV representative. She also handed out two news articles that are attached.

Member Wofford hosted an ag tour for Assemblyman Kevin Kiley.

Member Krakow is an Ambassador of El Dorado Hills. He meets with the Chamber and attends events on a regular basis.

Member Lobaugh works in the wireless industry and they've approved approximately 53 different communication projects. One project is in the greater Lake Tahoe Basin and six projects are in the County. They will be using existing infrastructure and placing antennas on the Liberty and PG&E poles.

Member Wood was elected as Director for the Cameron Park Community Services District on November 6, 2018. She volunteered her time to help the animals in Gridley following the Campfire. She is looking into training opportunities for the County.

Member Payne has been working with a non-profit group, Save the Graves. They help keep up the Pioneer Cemeteries. He also updated the committee on the El Dorado Arts Council. They recently moved onto Main Street and are promoting different types of cultural resources. They also created an incubator system to help startup non profits, like Save the Graves.
